Subject: Diversion of 4.645 ha. of forest land in Sy.No. 87 (1.675 ha) and Sy.No. 88 (2.97 ha), Goravinakallu village, Kasaba Hobli, Hosadurga Taluk, Chitradruga District for laying of 66 KV DC line from proposed 220 KV Hosadurga Line to link existing Halurameshwara 66 KV SC line near Honnenahalli limits for a distance of 8.553 Kms (new corridor) in favour of the Executive Engineer, Major Works Division, Karnataka Power Transmission Corporation Ltd, Chitradurga -reg.

## Sir,

I am directed to refer to the State Government's letter No. FEE 75 FLL 2019 (e) dated 25/11/2020 seeking prior approval of the Central Government under Section'2' of the Forest (Conservation) Act, 1980 for the above project.

After careful examination of the proposal of the State Government, in-principle approval /Stage-I clearance of the Central Government is hereby granted for diversion of 4.645 ha. of forest land in Sy.No. 87 (1.675 ha) and Sy.No. 88 (2.97 ha), Goravinakallu village, Kasaba Hobli, Hosadurga Taluk, Chitradruga District for laying of 66 KV DC line from proposed 220 KV Hosadurga Line to link existing Halurameshwara 66 KV SC line near Honnenahalli limits for a distance of 8.553 Kms (new corridor) in favour of the Executive Engineer, Major Works Division, Karnataka Power Transmission Corporation Ltd, Chitradurga, subject to the following conditions:-

## A: Conditions which need to be complied prior to handing over of forest land by the State Forest Department.

- The User Agency shall transfer online, the Net Present Value (NPV) of the forest land being diverted under this proposal, as per the orders of the Hon'ble Supreme Court of India dated 28.03.2008, 24.04.2008 and 09.05.2008 in Writ Petition (Civil) No.202/1995 and the guidelines issued by this Ministry vide its letter No. 5-3/2007-FC dated 05.02. 2009. The requisite funds shall be transferred through online portal into CAMPA account of the State Concerned;
- 2. The User Agency shall transfer the cost of raising and maintaining the Compensatory Afforestation over double the extent of degraded forest land in Sy.No. 1, Kudrekanive village, Srirampura Hobli, Hosadurga Taluk, Chitradurga District at the current wage rate in consultation with State Forest Department in the account of CAMPA of the concerned

State through online portal. The scheme may include provision for watering and SMC works and appropriate provision for anticipated cost increase for works scheduled for subsequent years;

- 3. All the funds received from the user agency under the project shall be transferred/deposited in CAMPA account only through e-portal (https://parivesh.nic.in/). Amount deposited through other mode will not be accepted as compliance of the Stage-I clearance.
- 4. The compliance report shall be uploaded on e-portal (<u>https://parivesh.nic.in/</u>).
- 5. The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector;
- 6. The boundary of the diverted forest land shall be demarcated on ground at the project cost, by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number, distance from pillar to pillar and GPS co-ordinates;
- 7. The User agency in consultation with the State Forest Department shall prepare a detailed scheme for creation and maintenance of plantation of dwarf species (preferably medicinal plants) in right of way under the transmission line for execution of the said scheme to the State Forest Department.
- Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as prescribed in para 1.21 of Chapter 1 of the Handbook of comprehensive guidelines of Forest (Conservation) Act, 1980 as issued by this Ministry's letter No. 5-2/2017-FC dated 28.03.2019;

## B: Conditions which need to be strictly complied on field after handing over of forest land to the user agency by the State Forest Department but the compliance in form of undertaking shall be submitted prior to Stage-II approval:

- 1. Legal status of the diverted forest land shall remain unchanged;
- 2. Compensatory Afforestation shall be raised over double the extent of degraded forest land within three years from the date of Stage –II Clearance and maintained thereafter by the State Forest Department at the cost of the User Agency and at least 1000 plants per hectare shall be planted over identified degraded forest land within three years of grant of final approval. If it is not possible to plant so many saplings in the area identified for CA, the balance saplings will be planted in any other forests as per prescriptions of approved working plan with provision for ten years on subsequent maintenance.
- 3. At the time of payment of the Net Present Value (NPV) at the then prevailing rate, the User Agency shall furnish an undertaking to pay the additional amount of NPV, if so determined, as per the final decision of the Hon'ble Supreme Court of India;
- 4. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.

- 5. No labour camp shall be established on the forest land.
- 6. Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.
- 7. The user agency at its cost shall provide bird deflectors, which are to be fixed on upper conductor of transmission line at suitable intervals to avoid bird hits.
- 8. The User Agency shall comply with the guidelines for laying transmission lines through forest areas issued by Ministry vide letter no. 7-25/2012-FC dated 05/05/2014 & 19/11/2014.
- 9. The forest land proposed to be diverted shall under no circumstances be transferred to any other agency, department or person without prior approval of the Central Government;
- 10. No damage to the flora and fauna of the adjoining area shall be caused;
- 11. The layout plan of the proposal shall not be changed without the prior approval of the Central Government;
- 12. The concerned Divisional Forest Officer, will monitor and take necessary mitigative measures to ensure that there is no adverse impact on the forests in the surrounding area.
- 13. The user agency shall ensure that any tree felling shall be done only when it is unavoidable and that too under strict supervision of the State Forest Department;
- 14. The User Agency shall submit the annual self -compliance report in respect of the above stated conditions to the State Government and Integrated Regional Office, Bangalore by the end of March every year; and
- 15. The user agency shall comply with all the provisions of the all Acts, Rules, Regulations, Guidelines, Hon'ble Court Order (s) and NGT Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project.

After receipt of compliance report on fulfilment of the conditions mentioned above, the proposal shall be considered for final approval under Section-2 of the Forest (Conservation) Act, 1980. Transfer of forest land shall not be effected till final approval is granted by the Central Government in this regard.
