With reference to the captioned subject, it is to intimate you that the Financial outlay for CA Scheme over an area 4.560 ha. of Non-forest land identified in Village Sanadhaura Gotha under Deogarh Forest Division pertaining to the above project amounting to **Rs.18,36,100.00/- (Rupees Eighteen Lakh Thirty Six Thousand One Hundred) only** has been technically approved by Addl. PCCF (FD & No, FC Act) at the wage rate of Rs.213.50/- Man day with 10 years maintenance . This fund was deposited by you vide UTR No. SBIN 818156593425 dt.05.06.2018.

Due to revision of wage rate from Rs.213.50/- MD to Rs.311/- MD the above financial outlay of CA Scheme has been revised and technically approved by Addl.PCCF (FD & NO, FC Act) for **Rs.23,56,700/- (Twenty Three Lakh Fifty Six Thousand Seven Hundred) only**.
