Sub: - Diversion of 4.545 ha. of Revenue Forest Land for construction of Pallahara Bypass Road coming within the stretch Km 0.000 to Km 68.280 under the project "Rehabilitation and Up gradation of NH-149 from Pallahara to Pitri section to two lanes with paved shoulders under NHPD- IV in the State of Odisha on EPC mode" under Deogarh Forest Division in Angul District, Odisha-Deposit of revised differential cost of Site-Specific Wildlife Conservation at the current wage rate of Rs.333/- per MD-regd.

Sir,

With reference to memo cited above on the captioned subject, it is to inform you that the financial outlay for Site Specific Wildlife Conservation Plan pertaining to the above project amounting to Rs.1,36,00,000/- (Rupees One Crore Thirty-six Lakhs) only had been approved by PCCF (WL) & CWLW, Odisha, Bhubaneswar at the wage rate of Rs.200/- per Man Day with 10 years maintenance. This fund had been deposited by you vide UTR No.SBINR 118319590758 dt.15.11.2018 in ODISHA CAMPA Account bearing A/C No.150826117128820 as communicated to this office vide your Letter No.2963 dt.15.11.2018.

In the meantime, due to revision of wage rate from Rs.200/- MD to Rs.333/- MD, the cost of the above financial outlay of Site-Specific Wildlife Conservation Plan has been revised to Rs.1,64,03,575/- (One Crore Sixty-four Lakhs Three Thousand Five Hundred Seventy-five) only.

Therefore, you are requested to deposit the differential amount of Rs.28,03,575/- (Rupees Twenty-eight Lakhs Three Thousand Five Hundred Seventy-five) Only (Rs. 1,64,03,575.00 – 1,36,00,000.00) against Site-Specific Wildlife Conservation Plan for payment through web portal of MoEF & CC and submit the deposit particular in CAMPA format to this office for taking further action at this end.
