01. Whereas the total Revenue Forest of 4.16 Ha lies in Subarnapur Forest Division as per following classification.

02. Where as condition No. 5 of the approval granted by Government of Odisha, Forest & Environment Department ,U/S- 2 of Forest (Conservation) Act-1980 communicated to this office vide memo no. No. 27737 Dt. 26.12.2018 & to your office memo No. 27740 Dt. 26.12.2018 from Special Secretary to Government of Odisha, F&E Department provides that NPV of the entire revenue forest land is to be deposited by the User Agency, i.e. The District Education Officer, Subarnapur.
03. Whereas the above revenue forest area 4.16 ha fall under Eco-value Class-III, and the canopy density has been reported to be 0 (Open Forest) in Subarnapur Forest Division, for which NPV to be charged @ Rs. 6,26,000/- (Rupees six lakhs twenty six thousand) only as per circular Letter No. 21687/F&E dated 22.12.2009 the F&E Dept. addressed to the Pr. CCF, Odisha, Bhubaneswar, the total NPV comes to Rs. 26,04,160/- (Rupees twenty six lakhs four thousand one hundred & sixty) only (4.16 ha X 6.26 Lakh).
04. Now therefore, the undersigned, hereby issues demand notice for payment of **Rs. 26,04,160/- (Rupees twenty six lakhs four thousand one hundred & sixty) only** towards NPV .

05. The NPV is to be deposited through e-portal of MOEF & CC as provided in the <http://forestclearance.nic.in> by RTGS / NEFT in Account No. CA 1585 in favour of Compensatory Afforestation Fund in Corporation Bank, Lodhi Road, New Delhi and submit the proof with seal & signature of the issuing bank to this office for needful.
06. It is further ordered that in the event of upward revision of NPV, an undertaking to pay the differential amount is to be submitted by the User Agency as stipulated in Hon'ble Supreme Court Guideline.
