विषय: जनपद मीरजापुर के कैमूर वन्यजीव प्रभाग के हलिया रेंज के अन्तर्गत प्रान्तीय खण्ड, लोक निर्माण विभाग, मीरजापुर द्वारा भटवारी-मतवार सम्पर्क मार्ग, मतवरिया-मतवार सम्पर्क मार्ग, बढौही परसिया वाया औरा सम्पर्क मार्ग, फुलियारी सम्पर्क मार्ग, सिलहटा सम्पर्क मार्ग, मेंजा बाध (ददरी) से नदना वाया मटिहरा-सगरा सम्पर्क मार्ग व खरिहट खुर्द से केडवर सम्पर्क तक सम्पर्क मार्ग में प्रभावित 34.902 हे० आरक्षित वनभूमि के गैरवानिकी प्रयोग एवं बाधक 156 वृक्षों के पातन की अनुमति के सम्बन्ध में।

महोदय,

कृपया उपरोक्त विषयक सचिव (वन), उत्तर प्रदेश शासन के पत्रांक पी-146/81-2-2023-800(173)/2023, दिनांक 27.06.2023 का आशय ग्रहण करने का कष्ट करें, जिसके द्वारा विषयांकित प्रकरण में राज्य सरकार द्वारा वन (संरक्षण एवं संवर्धन) अधिनियम, 1980 के अन्तर्गत भारत सरकार की स्वीकृति माँगी गयी थी।

प्रकरण को दिनांक 07.03.2024 को आहूत की गई क्षेत्रीय सशक्त समिति (REC) की बैठक में (REC Agenda item 4.1-UP) शामिल किया गया था। क्षेत्रीय सशक्त समिति के निर्णयानुसार प्रकरण में स्वीकृति प्रदान की गयी है। प्रकरण में विचारोपरान्त मुझे आपको यह सूचित करने का निर्देश प्राप्त हुआ है कि केन्द्र सरकार जनपद मीरजापुर के कैमूर वन्यजीव प्रभाग के हलिया रेंज के अन्तर्गत प्रान्तीय खण्ड, लोक निर्माण विभाग, मीरजापुर द्वारा भटवारी-मतवार सम्पर्क मार्ग, मतवरिया-मतवार सम्पर्क मार्ग, बढौही परसिया वाया औरा सम्पर्क मार्ग, फुलियारी सम्पर्क मार्ग, सिलहटा सम्पर्क मार्ग, मेंजा बाध (ददरी) से नदना वाया मटिहरा-सगरा सम्पर्क मार्ग व खरिहट खुर्द से केडवर सम्पर्क तक सम्पर्क मार्ग में प्रभावित 34.902 हे० आरक्षित वनभूमि के गैरवानिकी प्रयोग एवं बाधक 156 वृक्षों के पातन की सैद्धांतिक स्वीकृति निम्नलिखित शर्तों पर प्रदान करती है:-

1. Legal status of the forest land shall remain unchanged.
2. Compensatory afforestation shall be taken up by the Forest Department in an area of **40.87 ha. (NFL)** Non Forest Land at the cost of the User Agency. As far as practicable a mixture of local indigenous species will be planted and monoculture of a species has to be avoided. The details of CA are as follows:-

3. The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with the Forest Department by the project authority. The CA will be maintained for 10 years. The scheme will be for plantation and may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.
4. Forest land will be handed over only after required non-forest land for the project is handed over by the user agency.
5. The non-forest land proposed for CA shall be transferred and mutated in the name of Forest Department and notified as RF/PF prior to Stage-II approval. A copy of the original notification declaring the non-forest land under Section 4 or Section 29 of the Indian Forest Act, 1927, or under the relevant section of the State Forest Act as the case may be, will be submitted by the State Government at the time of submission of compliance of AIP.
6. The State Government shall charge the Net Present Value (NPV) for the 34.902 ha. forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-1/1998-FC (Pt.II) dated 18/09/2003, as well as letter No. 5-2/2006-FC dated 03/10/2006, 5-3/2007-FC dated 05/02/2009 and 5-3/2011-FC (Vol-I) dated 06.01.2022 in this regards.
7. Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.
8. User agency shall restrict the felling of trees to 156 trees/minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
9. The user agency to explore transplanting of trees in consultation and guidance of Forest Department and monitoring/assessment of success of such transplanted trees by Research Wing of Forest Department. The details and location of such transplanted trees shall be submitted.
- 10. CA site proposed for plantation on Non-Forest Land falls in Kaimur Wild Life Sanctuary, CA shall be as per prescriptions of Wild Life Management plan.**
- 11. CA has been proposed on equivalent Non Forest Land (NFL) in which only 29.99 ha. Is found suitable for plantation (as per DSS report), rest of plantation (CA) needs to be proposed on DFL. Accordingly KML file of DFL shall be uploaded on Parivesh Portal.**
- 12. Boundaries of forest area shall be rectified on DSS portal.**
13. No violation of Forest (Conservation) Act, certificate from concerned DFO shall be provided.
14. The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
15. Plantation shall be raised on both sides of the road and median (if available) by the State Forest Department at the cost of User Agency as per submitted scheme according to IRC guidelines and order passed by NGT in OA no. 27/2015 in the matter of Babulal Jaju v/s State of Rajasthan and others dated 16.11.2015.
16. Speed regulating signage will be erected along the road at regular intervals in the Protected Areas/ Forest Areas.
17. The user agency shall provide suitable under / over pass in Protected Area / Forest Area as per recommendations of CWLW / NBWL / FAC / REC.
18. User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.
19. The layout plan of the proposal shall not be changed without prior approval of Central Government.
20. No labour camp shall be established on the forest land.
21. Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.

22. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
23. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
24. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.
25. The forest land shall not be used for any purpose other than that specified in the project proposal.
26. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.
27. The KML file of area proposed for diversion and area proposed for plantation shall be uploaded on the E-Green watch portal with all requisite details before commencement of works.
28. Any order of Temporary Work Permission in case of linear projects for tree cutting and commencement of work as per clause 11.2 of FCA Guidelines shall be passed under intimation to Nodal office and this office. Order of Temporary Work Permission have to be uploaded on PARIVESH Portal as well. Nodal Officer will strictly monitor and ensure that no further activity is carried out under such permission after the expiry of one year from the date of issue of such permission.
29. The violation of any of the conditions stipulated under this approval will be liable to the cognizance and appropriate action under MoEFCC rules and Guidelines as applicable, specifically MoEFCC Guidelines dated 15/05/2023, authorizing officers of the rank of Divisional Forest Officer (DFO)/Deputy Conservator of Forests (DCF) and above of the State Government or Union territory Administration concerned, having jurisdiction over the forest land in respect of which any offence under the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 is committed or violation of the provisions of the said Act has been made, to file complaints against such person/authority/organization, prima-facie found guilty of offence under the Act or the violation of the rules made thereunder, in the court having jurisdiction in the matter.
30. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
31. All the funds received from the user agency under the project shall be transferred/ deposited to CAMPA fund only through **e-portal** (<https://parivesh.nic.in/>).
32. **In view of enforced Model Code of Conduct, all the rules, procedure and guidelines in force shall be followed.**
33. The compliance report shall be uploaded on **e-portal** (<https://parivesh.nic.in/>).

After receipt of compliance report on fulfillment of all of the above conditions from the State Government, proposal will be considered for final approval under Section-2 of the Forest (Conservation) Act, 1980, by this office.

The order for transfer of forest land to user agency shall not be issued by the State Government till final approval order for diversion of forest land is issued by Government of India.
