Wherein the Government of Tamil Nadu has conveyed the Government's in Principal approval (Stage – I) under section 2 of Forest (Conservation) Act, 1980 for diversion of 0.12 Ha of Forest land in Karmangudi Reserved Forests for laying Pipe line providing drinking water supply for Tittakudi, Pennadam, Mangalampettai, Gangaikondan , vadalore , Kuringipadi , 625 Rural habitation in in Vridhachalam, Nallur, Mangalore Union in Cuddalore District. Favour of Executive Engineer, TWAD Board Cuddalore. Laying of pipe line period of 25 years, under general approval category as per the provision under Forest (Conservation) Act, 1980, subject to the follow us condition
