DEMAND NOTICE

Sir,

Sub: TSFD - F(C) Act, 1980- PMGSY roads (PR Department) Diversion of 2.43 Ha of forest land for road network in LWE effected area from "R&B road to Tippapuram" from 0/0 to 6/880 of Alubaka RF of Venkatapuram Division , Mulugu District in favour of District Panchayath Raj Engineer, P.I.U. Division Mulugu, Mulugu District - In-Principal (stage-I) approval - **accorded**- communication of orders for compliance - Regarding.

It is submitted that the Prl. Chief Conservator of Forests (HoFF), Hyderabad vide reference 2nd cited has informed that the Govt of India vide reference 1st cited have accorded in principle (Stage-I) approval for Division of 2.43 Ha. of Forest Land for road network in LWE effected area from R&B Road to Thippapuram from 0/0 to 6/880 of Alubaka RF of Venkatapuram Division, Mulugu District in favour of District Panchayath Raj Engineer P.I.O Division Mulugu, Mulugu District (User Agency) subject to condition stipulated therein and requested to issue the demand notice for making payment compensatory levies over the User Agency in consultation with the Nodal Officer (FCA) and obtain the compliance report from the User Agency and furnish through Chief Conservator of Forests, Warangal for obtaining the stage-II (final) approval from the Government..

As per the conditions the user agency has to pay following amounts(demand notice).

The user agency should deposit the above amount through Ministry's portal i.e., <http://parivesh.nic.in> into Adhoc CAMPA account through ministry's portal by uploading the demand notice against the proposals for approved by Nodal officer FCA and then challan has to be generated and amount is to be deposited against the challan number. The payment to be made against the Challan number and the Challan is valid for one week. A step-by-step process is available at <http://parivesh.nic.in>.

Further, the User Agency will be requested to comply with following in accordance with the MoEF&CC, GoI instructions issued vide F.no.7-23-2012-FC, Dt.24.07.2013 communicated vide Prl. Chief Conservator of Forests, A.P. Hyderabad Rc.No.45921/2001/F4, Dt.23.08.2013:

- Publish the entire forest clearances granted in verbatim along with the condition and safe-guards imposed by the Central government in two widely circulated daily newspaper one in vernacular language and the other in English granted to the project proponent for the use of forest land for the non-forest purposes.
- The copies of the forest clearance should also be submitted to the heads of local bodies, Panchayats and municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days.


Further, the UA will be requested to furnish the undertakings for conditions (i),(iv), (v), (vii), (viii), (ix), (x), (xi), (xii), (xiii), (xiv), (xv), (xvii), (xviii), (xix), (xx) and note the other conditions strictly as per the plan prepared by the forest department.

The transfer of forest land to User Agency shall not be affected prior to the issue of final (Stage II) approval or working permission (for tree felling and execution of linear projects).

The User Agency will be informed that for issued of working permission by the competent authority only when all such other compensatory levies specified in the Stage-I (in-principle) approval are realized from the UA including transfer and mutation of CA lands identified in the name of the forest department in case CA lands are to be handed over.

In view of the above, it is requested to kindly approve the above demand notice for issuing to User Agency for making payment of above compensatory levies.


