

Further, you are requested to deposit the above amount of **Rs. 82, 69, 214/-** towards differential amount of NPV and submit compliance to the condition No.2 (v) of Stage-I approval order dt.18.06.2018 regarding compensatory Afforestation may be obtained from DFO, Kalahandi (North) Division & condition No.2(x) of stage-I approval order dt.18.06.2018, DGPS map with co-ordinate certified by ORSAC, Odisha to this Office at an early date for onward transmission to higher quarters.
