Madam/Sir,

I am directed to refer letter No. F-3/86/2017/10-11/12/5019 dated 26.09.2024 of the APCCF (LM) and Nodal Officer, Government of Madhya Pradesh on the above subject forwarding required information on the compliance of conditions stipulated in the Stage-I approval dated 29.08.2018 and to say that on examination of the said information following shortcoming have been observed: -

i. The State Govt. vide their letter dated 14.06.2022 has mentioned that the user agency has deposited an amount of Rs. 3,46,17,800/- towards NPV and now the State Govt. vide their letter dated 26.09.2024 has mentioned that in reference to the differential amount of NPV to be paid as per the revised rates of NPV the user agency has deposited an amount of Rs. 3,33,23,227/- online in CAMPA account. This signify that a total of Rs. 6,79,41,027/- has been deposited by user agency towards NPV online in CAMPA account. However as per details mentioned in online Part-II of Parivesh portal against the instant proposal the density of the proposed forest area for diversion is reported as 0.4 having Eco-Class 5 and as per the revised NPV rates an amount of Rs. 7,14,94,605/- (Rs. 1292850/- per ha. for Eco-class 5 having 0.4 density x 55.3 ha area proposed for diversion) is to be realized from the user agencies in lieu of diversion of forest land. Therefore the differential amount of NPV of **Rs. 35,53,578** /- (Rs. 7,14,94,605 - Rs. 6,79,41,027) shall be deposited online in CAMPA account.

Accordingly, it is requested to furnish the above-mentioned information to this Ministry for further consideration of the proposal.
