
Sir,

With reference to above, this is to inform you that the Site Specific Wildlife Conservation Plan for construction of Kala Barrage Irrigation Project of IB Investigation Division, Sundargarh under Bonai Forest Division & Deogarh Forest Division in Sundargarh & Deogarh District, Odisha has been approved by the PCCF (WL) & CWLW, Odisha with financial outlay of ₹731.881 Lakhs (Bonai Division-228.579 Lakh + Deogarh Division-503.302 Lakhs) for the activities to be implemented by Bonai Forest Division and Deogarh Forest Division. So, you are requested to deposit of **₹228.579 Lakhs** only through e-portal of MoEF & CC as provided in the <http://parivesh.nic.in>, and submit the original proof with seal and signature of the issuing Bank to this office for needful.

Besides, it has further required to take note of the following conditions for future compliance.

1. Activities in the project area as per Chapter-IV of the Plan will be executed by the project proponent under the guidance of DFO, Deogarh / Bonai Forest Division, as the case may be.
2. The plan period is for five years and will be revisited by concerned DFOs at least one year before expiry of its implementation. The User Agency will bear the cost of such plan on its approval. Further, the User Agency will bear additional cost, if any, towards enhancement of wage rate and escalation of price of materials at the time of implementation of this plan. In case of any deviation, it will be dealt as per law for violation of Forest (Conservation) Act'1980, Environment (Protection) Act'1986 and Wildlife (Protection) Act,1972.

3. The Plan period is five years and will be revisited by concerned DFOs at least one year before expiry of its implementation. The User Agency will bear the cost of such Plan on its approval. Further, the User Agency will bear additional cost, if any, towards enhancement of wage rate and escalation of price of materials at the time of implementation of this Plan. In case of any deviation, it will be dealt as per law for violations of Forest (Conservation) Act 1980, Environment (Protection) Act 1986 and Wildlife (Protection) Act 1972.


