## Demand Notice for differential CA & other charges

With reference to the above subject, the Government of India, Ministry of Environment, Forest & Climate Change (Forest Conservation Division), New Delhi has accorded Stage-I / In-principal approval for diversion of 15.981 ha of forest land in RM Block and other villages for Approach Road, Downhill Pipe Conveyor (DPC) and Feed & Transfer point area for Rama Iron Ore Mine [MLNo.009(2621)] in favour of M/s JSW Steel Ltd. Torangallu imposing certain conditions vide letter under Ref (1).

Further, the Principal Chief Conservator of Forests (FC) and Nodal Officer (FCA), Aranya Bhavan, Bengaluru has directed the undersigned to issue Revised demand for Compensatory Afforestation and Raising of Avenue Plantation and submit the revised compliance report to Condition No. IV, IX, X & XXVII vide letter under Ref(6).

Further, there is a revision in the CA charges [Common Sanctioned Schedule of Rates (CSSR) in the year 2021-22] notified vide letter under reference (4). The differential Compensatory Afforestation and Raising of Avenue Plantation charges as applicable for the above referred proposal are calculated as here under;
