With reference to the above subject, the Government of India, Ministry of Environment, Forest & Climate Change (Forest Conservation Division), New Delhi has accorded Stage-I / In-principal approval for Diversion of 4.74 hectare of forest land in DM Block, Sandur Taluk, Ballari District for use of existing approach road to MLNo. (0004) 2366 in favour of M/s. JSW Steel Limited, Toranagallu imposing certain conditions vide letter under Ref (1).

Further, the Principal Chief Conservator of Forests (FC) and Nodal Officer (FCA), Aranya Bhavan, Bengaluru has directed the undersigned to issue Revised demand for Compensatory Afforestation and SMC works charges vide letter under Ref(5).

Further, there is a revision in the CA charges [Common Sanctioned Schedule of Rates (CSSR) in the year 2021-22] notified vide letter under reference (4). The differential Compensatory Afforestation, SMC works charges and Raising of Avenue Plantation charges as applicable for the above referred proposal are calculated as here under;
