Attention is invited to the above subject. Government have accorded sanction for the diversion of 0.032262 ha of forest land located in Chandramala Estate of Pulayampara area, which is leased out reserve forests under Nelliyampathy Forest Station of Nelliyampathy Range in Nemmara Division for constructing Telephone Tower to provide internet connectivity to Tribal villages in Nelliyampathy Hill Area under Nelliyampathy Grama Panchayath in Palakkad District vide order 1st cited and directed to issue the demand notice to the User Agency for remitting NPV and submitting the undertaking in stamp paper worth Rs.200/- stating all the conditions are complied in the stage – I approval vide reference 2nd cited above.

In the light of above orders, <u>NPV amount of Rs.51, 484/- for 0.032262 ha</u> (Proposed project area falls under Tropical Wet Evergreen Forests in Eco-Class-I category and the amount is Rs.15, 95,790/ Ha) to be remit through e-portal (PARIVESH) and necessary undertaking in stamp paper worth Rs. 200/- stating all the conditions are complied in the stage – I approval also to be submit to this office at the earliest.
