I wish to inform that the user agency i.e. the Executive Engineer, PR Division, Rajampet has submitted justification stating that the forest land required is a bare minimum area for the purpose and there will be no further requirement of additional area and also certified that, no suitable Private or Government non-forest is available at the site. The Principal Chief Conservator of Forests has reported that the user agency has not violated the provisions of Forest (Conservation) Act, 1980. The District Collectors of Kadapa has issued necessary certificates under Scheduled Tribes & Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006. The proposal has been uploaded on the Ministry's web site and unique file No. FP/AP/ROAD/30927/2017 has been generated. The concerned filed officers and the Principal Chief Conservator of Forests & Head of Forest Force, have recommended the proforma proposal in Part-II, III and IV respectively. The recommendation of the State Government in the proforma Part-V is enclosed with the proposal.

3. I request you to obtain and communicate the approval of Government of India, Ministry of Environment, Forests & Climate Change, under Section 2 of Forest (Conservation) Act, 1980, for diversion of 1.77 Ha of forest land for formation of road from Baggidiapalli to Yakaropalli Village, Pulaputhur Gram Panhayat of Rajampet Division, in favour of Executive Engineer, PR Division, Rajampet, at an early date.
