In compliance to the kind Prl. Chief Conservator of Forests (HoFF), Telangana, Hyderabad instructions issued in the reference 3rd cited, it is informed that, the Government of Telangana, EFS&T, (For-I) Dept vide reference 2nd cited above has accorded the in-Principle (Stage-I) approval for diversion of 0.803 Ha of Forest land for excavation of Canals of LMC-RD3 and LMC-RD3-LM6 passing through Sy. No. 433/1/1 of Dacharam CA land in Dacharam Village, Ellathankunta Mandal, Rajanna Sircilla District in favour of Executive Engineer, Kaleshwaram Project Construction, Project Division No. 1, Siddipet, I&CADD.

The User Agency has to deposit an amount of Rs. 40, 04,597/- (Rupees Forty lakhs four thousand five hundred and ninety-seven only) through online mode only in the Telangana State Compensatory Afforestation Fund Management and Planning Authority (CAMPFA) saving bank Account. The payment has to be made through e-portal method at MoEF&CC, GOI, New Delhi portal i.e., forestsclearance.nic.in by generating the challan in consultation with Nodal Officer, Telangana State Forest Department. For this the user agency has to upload the demand notice against the project for approval of the Nodal Officer (FCA) and generate challan after approval and deposit the funds into the account number mentioned on the challan. Step-by-step procedure is available at Ministry' portal.

The User Agency has to deposit an amount of Rs. 7,76,226/- (Rupees Seven Lakhs Seventy Six thousand Two hundred and Twenty Six only) into the PD Account of District Forest Officer, Rajanna Sircilla & Karimnagar bearing No. 1212483384 in Kotak Mahindra Bank, Alugunur Branch, Karimnagar. IFSC: KKBK0007801.

Further, the User Agency has to comply with following in accordance with the MoEF&CC, GoI instructions issued vide F.no.7-23-2012-FC, Dt.24.07.2013 communicated vide Prl. Chief Conservator of Forests (HoFF), Hyderabad Rc.No.45921/2001/F4, Dt.23.08.2013:

1. Publish the entire forest clearances granted to the project proponent for the use of forest land for the non-forest purposes in verbatim along with the condition (s) and safe-guards imposed by the Central government in two widely circulated daily newspaper i.e., one is vernacular language and the other in English.
2. The copies of the forest clearance should also be submitted to the heads of local bodies, Panchayats and municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days from the date of receipt of this reference.

The user agency will be requested to comply with the other conditions as directed in ref 1st and 2nd cited and submit the compliance report on the conditions stipulated by the Govt. for obtaining Stage II (final) approval.

Further it informed that, the transfer of forest land to User Agency shall not be affected prior to the issue of final (Stage II) approval / working permission and no work in violation shall be carried out.
