Sir,

With reference to the above cited memo on the subject, it is to inform you that, the Compensatory Afforestation scheme over an area of 12.0 Ha. of degraded forest land identified in Baliakhada RF against the above project amounting to Rs. 97,07,500/- (Rupees Ninety seven lakh seven thousand five hundred) only was approved by the PCCF(FD&NO, FC Act.) at the wages Rs. 311/- per Mandays with 10 year maintenance. Further, it is to inform you that, this office has prepared the financial outlay as per instruction of the Pr.CCF, Odisha, Bhubaneswar <sup>which</sup> comes to Rs. 97,89,672/- as per enhanced wage rate @ Rs. 315/- per MD and the differential C.A. cost of Rs. 82,172/- was demanded to you which has been deposited by you on 25.01.2022.

Now due to enhancement of wage rate, the above financial outlay of CA scheme has been revised at the wage rate of Rs. 326/- per MD and approved by the Chief Conservator of Forests (FD&NO, FC Act) to Rs. 1,03,41,700/- (Rupees One Crore three lakh forty one thousand seven hundred) only.
