The Additional Principal Chief Conservator of Forests and Nodal Officer has submitted proposal for diversion of 16.6846 ha. forest land for construction of third Railway line between Kalyan to Kasara stations of 67.62 km in Ulhasnagar, Kalyan and Shahapur Talukas in Thane District.

3. The Deputy Chief Engineer (C), Ghatkopar, Central Railway has submitted diversion of 16.6846 ha. forest land for proposed 3rd Railway Line between Kalyan to Kasara Stations of 67.62 Km. in Ulhasnagar, Kalyan and Shahapur Talukas. Thane District in the State of Maharashtra. The Kalyan-Kasara (67.62 Km) is electrified double line section of Mumbai Division. This corridor is known as the North-East Main Lines and is a part of CSTM-HWH Group 'A' route. It is divided into 3 sub-sections viz., Kalyan-Titwala (10.84Kms), works on Automatic Block Signaling, Titwala- Asangaon (21.38Kms) and Asangaon-Kasara (35.4Kms) both work on Absolute Block System. All the three streams of traffic viz. Suburban, Mail / Express and freight trains use the same pair of lines between Kalyan & Kasara. Beyond Titwala, the section has a highly undulating terrain with ruling gradient of 1 in 90 in DN direction and 1 in 132 in UP direction. The forest area demanded is barest minimum requirement for the said project. Total non-forest involved in the project is 28.6067 ha.

# 4. Deputy Conservator of Forests, Shahapur, Thane, Thane (WL) have certified that:-

- 4.1 No suitable alternate land is available and the forest land required is lowest minimum.
- 4.2 The area belongs to Eco-value class-I having density 0.2 to 0.4 (Open Forest / Dense Forest).
- 4.3 There are 1100 trees of various species and trees are involved in implementation of the Project.
- 4.4 Proposed project is within 10 km default Eco-Sensitive Zone of Tansa Wildlife Sanctuary, 6.557 km from Tansa Wildlife Sanctuary and 0.1423 km from core boundary of Tansa Wildlife Sanctuary in Thane Wildlife Division.
- 4.5 Proposed project is not likely to affect any monumental site of cultural, historical, religious, archaeological or recreational importance.
- 4.6 There is no violation of Forest (Conservation) Act 1980.
- 4.7 Compensatory Afforestation is proposed over 1.00 ha. degraded Forest land in Survey No.419, Compt No. 1144 at Village Panchpakhadi, Taluka and Dist. Thane and it is contiguous, suitable for afforestation and management purpose and it is free from encroachment and an encumbrances

# 5. The User Agency has submitted undertakings:-

- 5.1 to defray the cost of compensatory afforestation.
- 5.2 to defray the cost of Net Present Value of the forest land.

- 5.3 to submit the compliance under the Scheduled Tribes and Other Traditional forest Dwellers (Recognition of Forest Rights) Act, 2006.
- Principal Chief Conservator of Forests (Wildlife) & CWLW has informed that project 6. requires wildlife clearance.
- The Principal Chief Conservator of Forests (HoFF), Maharashtra State, Nagpur has 7. recommended the proposal subject to the conditions, given in his specific recommendations, under Section-2 (ii) of the Forest (Conservation) Act, 1980. His specific recommendations are enclosed in the proposal.
- In the circumstances explained in above paragraphs and enclosures, the State 8. Government recommends that the said forest land may be allowed to be diverted for the non-forestry use subject to the conditions proposed by Principal Chief Conservator of Forests (HoFF), Maharashtra State, Nagpur.

The matter may kindly be placed before Government of India for its approval under Section-2 (ii) of the Forest (Conservation) Act,1980 and the same may please be obtained and communicated to this Government.
