This office has given an "In-Principal" approval for diversion of 1.9575 ha of protected forest land for laying OPTICAL FIBER CABLE with Protection pipes along the road from Godhra Telephone Exchange to Lunawada Telephone Exchange 48F OFC Route (43500 Mtr-1.9575 ha.) on Godhra-Lunavada highway-SH-5 road for vide this office latter dated: referred aboved at (2).

The BSNL Sub Divisional Engineer, Telecom Project, Vadodara has Reported that it has deposited an amount of Rs. 9000/- toword the cost of Processing Fee & Registration Fee (4000+5000=7400/-) in the 8782- Forest Remittance, account of Deputy Conservator of forest, Social Forestry Division, Godhra's D.D.O. No:982 Cardex No:2101 on date: 18/05/2022 confirmed by challan/bank receipt received vide letter dated 20/05/2022 of (BSNL Sub Divisional Engineer, Telecom Project, Vadodara.)

The Undersigned is pleased to convey the formal Approval of the Government under Section-2 of the Forest (Conservation) Act, 1980 Subject to the following condition:

- 1. FRA, if applicable will be complied by the user agency.
- 2. This permission is grantedon condition that the FRA certificate of the Collector is made compulsory in future.
- 3. This permission is granted only for use of the forest land for the purpose specified in the proposal. The legal status of the forest land shall remain unchanged.
- 4. The forest land shall not be used for any purpose other than that specified in the FCA proposal.
- 5. The user agency will have to obtain permission from the undersigned for carrying out any maintenance works in future.
- 6. The user agency will have to make good the forest land after use/maintenance work. No tree shall be cut.
- 7. The user agency will be liable to make good any loss to Forests/Environment caused due to the use of the said land by the user agency.
- 8. The line will be laid underground in a trench of depth of 1.65 Meters and width of 0.45 mtr in between rows of road side plantation.

- 9. Any other condition, which the Nodal officer (FCA)/the State Government may stipulate from time to time.
- 10. Work Will be carried out manually
- 11. User agency will be responsible for any loss to Forest/Environment caused due to the use of the said land by the User Agency.
