Further it is to inform that, as per the minutes of the meeting the Proposal for use of 21.2642 ha of forest land falling in the Tiger Corridor for laying of new 3rd BG railway line along the existing tracks within the railway boundary between Makhudi and Rechini Road Railway stations in KB-Asifabad & Mancherla Districts has been recommended subject to compliance of certain conditions and requested to issue demand notice to the User Agency.
