With reference to the subject cited above, this is to inform you that the Principal Chief Conservator of Forests, Forest Diversion & Nodal Officer, FC Act has technically approved the Compensatory Afforestation Scheme over an area 4.046 ha. of Govt. non forest land identified in village Khajurkhaman under Laikera Tahasil of Jharsuguda Forest Division. In addition to that an additional CA scheme has also technically approved over an area of 12.23 ha.of degraded forest land identified in Amkhaman Sagarpali RF of Jharsuguda Forest Division with a total financial outlay of Rs.26,72,800/- (Rupees twenty six lakh seventy two thousand eight hundred) only in lieu of diversion of the above mentioned forest land of 4.046 ha. In this regard, you are requested to deposit Rs.24,72,800(Rupees twenty four lakh seventy two thousand eight hundred) only towards the cost of CA in the state specific CAMPA Account maintained by Govt. of India through "E" Payment by using the Web Portal of Ministry of Environment & Forests (CAMPA) to fulfil condition No.2 A(ii) and (iii) of the Stage-I approval order. The evidence of depositing the amount may be forwarded to the undersigned for further needful action at this end.

Further, you are requested to deposit Rs.2,00,000/-(Rupces Two Lakh) only towards the cost of infrastructure, the Bank detail is given below:
