Sub: Div of 46.375 ha of forest land in favour of Executive Engineer, T.S Division, HVPNL Madanpur (Panchkula) for erection of 220 KV DC lines from 400 KC sub stn. Naggal (PGCIL) to 220 KV Sub stn sector 32 Panchkula and 220 KV sub Stn. Pinjore under Wildlife Sanctuary Khol Hi Raitan, under Forest Division Morni Pinjore and District Panchkula. (Online proposal FP/HR/ Trans/25376/2017))-regarding.

Sir,

Please refer to the above cited subject and letters seeking prior approval of the Central Government for diversion of forest land for non-forestry purpose in accordance with section 2 of the Forest (Conservation) Act, 1980.

- 2. After careful examination of the proposal of the State Government and recommendation of the REC, in-principle approval is hereby conveyed for diversion of 46.375 hectares of forest land for the above mentioned project, subject to the following conditions:
 - i) Cost of compensatory afforestation CA and Addl. compensatory afforestation may be realized from the user agency;
 - ii) Net Present Value (NPV) of the forest land being diverted for non-forestry purpose may be realized from the user agency, as per Ministry's directions issued vide letters No. 5-3/2007-FC dated 5th February 2009 and Hon'ble Supreme Court of India's Order dated 30th October 2002, 28th March, 2008, 24th April, 2008 and 9th May 2008;
 - As per the orders of the Government of India vide letter No. 5-2/2010-CAMPA 24.06.2011, the Net Present Value (NPV) of the forest land and all other CA levies shall be deposited through web portal of Ministry of Environment, Forest and Climate Change www.parivesh.nic.in;
 - iv) User agency should ensure that the compensatory levies (CA cost, NPV, etc.) are deposited through challan generated online on web portal and deposited in appropriate bank only. Amount deposited through other mode will not be accepted as compliance of the Stage-I clearance;

- v) The Divisional Forest Officer shall furnish undertaking that the approved CA site(s) will not be changed without the approval of competent authority;
- vi) The CEO State CAMPA shall furnish undertaking that the funds under State CAMPA will be released to Divisional Forest Officer as per approved CA scheme;
- vii) User Agency shall ensure that no other proposal in the division, for which Stage-I has already been granted in the past, is still pending for compliance of conditions of Stage-I approval. An Undertaking to this effect that "no such proposal for compliance of conditions of Stage-I approval is pending with this division" be submitted. Compliance of the same will be mandatory for the final clearance of this proposal by this office;
- viii) Original copy of FRA certificate be provided.
- 3. The following conditions shall also be complied with after the final approval is accorded:
 - i) Legal status of the forest land will remain unchanged;
 - ii) Efforts should be made to fell minimum number of trees not to exceed 9,913 trees & 2,840 plants;
 - iii) The trees should be felled under strict supervision of the State Forest Department;
 - iv) The CEO, State CAMPA Authority shall ensure release of funds under CAMPA to the DFO for raising CA plantation as per CA scheme approved by this office;
 - v) The DFO shall ensure taking up CA plantations at approved CA sites and shall not after the approved sites without obtaining the permission of the competent authority;
 - vi) The CA will be carried out over 92.750 ha on degraded forest land as per the CA scheme and the funds will be provided by the user agency. The plantation will be done within one year from the date of issue of the approval;
 - vii) The ACA will be carried out over 5.680 ha on degraded forest land as per the CA scheme and the funds will be provided by the user agency. The plantation will be done within one year from the date of issue of the approval;
 - viii) The User agency in consultation with the State Forest Department prepare a detailed scheme for creation and maintenance of plantation of dwarf species (preferably medicinal plants) in right of way under the transmission line for execution of the said scheme to the State Forest Department;
 - ix) The user agency at its cost shall provide bird deflectors, which are to be fixed on upper conductor of transmission line at suitable intervals to avoid bird hits. The User Agency shall comply with the guidelines for laying transmission lines through forest areas in letter & spirit;
 - x) User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable;
 - xi) The layout plan of the proposal shall not be changed without prior approval of Central Government;
 - xii) No labour camp shall be established on the forest land;
 - xiii) Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel;
 - xiv) The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less;
 - xv) No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work;
 - xvi) The forest land shall not be used for any purpose other than that specified in the project proposal;

- xvii) The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India; and
- xviii) Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
- After receipt of the compliance report on fulfillment of the conditions under para-2, above, final approval order shall be given under Section-2 of the Forest (Conservation) Act, 1980. The use of forestland will not be allowed till final approval is accorded.
