With ref. to the subject cited, through the reference 13th cited, the User Agency has accorded in-principle (Stage-I) approval for Diversion of Forest land to an extent of 0.9717 Ha (previously 0.567 Ha) of Forest land in Tumuloor Reserve Forest of Shamshabad Division for construction of approach road to reach the agricultural and farm lands from Srisailem Highway to Lemoor Village in favour of Tumfor Agrifarms LLP, Shaikpet Nala, Hyderabad subject to certain conditions stipulated therein and requested to furnish the compliance report on the conditions stipulated therein; which has been communicated in reference 13th cited and with instructions to raise the demand notice over the user agency for making payment of compensatory levies for deposition into respective account in consultation with concerned Circle Head; to obtain the compliance on the conditions stipulated from the user agency and furnish for onward submission to the Government for obtaining Stage II (final) approval.

Through this office ref.15th cited, draft demand was prepared and submitted to the Chief Conservator of Forests/ Conservator of Forests, Charminar Circle, Hyderabad for approval. The CCF/CF, Charminar Circle, Hyderabad vide ref.16th cited, has approved the same.

Accordingly, the demand is prepared as follows;

The user Agency has to upload the demand notice in the Ministry's portal against the project for approval by the Nodal Officer, FCA Telangana State. Further, the User Agency has to comply with following in accordance with the MOEF & CC, GoI instructions issued vide F.No.4-TSB298/2022-HYD/851, Dt:14.12.2022 communicated vide Prl. Chief Conservator of Forests, TS, Hyderabad Rc. No. FC1/FC03/9/2022(10724/2021/FCA1), Dt.04.01.2023.

1. Publish the entire forest clearance granted in verbatim along with the conditions and safe guards, imposed by the Central Government in two widely circulated daily newspapers one in vernacular language and the other in English granted to the project proponent for the use of forest land for the non-forestry purpose.
2. The copies of the forest clearance should also be submitted to the heads of local bodies, Panchayats and municipal bodies by the project proponents in addition to the relevant officers of the Government who in turn has to display the same for 30 days.

Further, the User Agency has to furnish the compliance on the conditions stipulated in the Stage-I approval for onward submission to Government for obtaining Stage-II approval.

The transfer of forest land to User Agency shall not be affected prior to the issue of final (Stage-II) approval/working permission and no work in violation of F (C) act 1980 and W (P) Act, 1972 shall be carried out.
