In compliance to the instructions contained in the ref. 4th cited, it is submitted that the Government of AP, in the ref.1st cited, has accorded in-principle (Stage-I) approval under F(C) Act, 1980 for diversion of 1.79ha of forest land in Prakasam (erstwhile Giddalur) Division for upgradation of NH-167B from Km.86/540 to Km 87/340 i.e Porumamilla to Chandrasekharapuram to two lanes paved shoulders under NHDP-IV in the State of Andhra in favor of Executive Engineer (R&B), NH Division, Kadapa subject to fulfillment of certain conditions laid down therein.

In this regard, as per conditions laid down by the Government of AP in reference 1st cited, the user agency has furnished the conditions wise compliance report through the DFO, Prakasam and the same report was submitted to the Prl. Chief Conservator of Forests, AP, Mangalagiri vide this office ref.3rd cited.

Further, it is submitted that in the reference 4th cited, the Prl. Chief Conservator of Forests, AP, Mangalagiri instructed that the Govt. of AP has accorded Stage-I/ in-principle approval on 30.11.2018 for the subject project, as per condition no.(viii) of Stage-I/ in- principle approval the validity of approval is for

5 years and it lapsed by 30.11.2023. The GoI, MoEF&CC (FC Division), New Delhi in F.no.5-3/2011-FC (Vol.I) dt.22.03.2022 have clarified that, revised NPV rates are applicable to all the cases where the stage-I approval is granted prior to 06.01.2022 and even after a lapse of 5 years Stage-II/final approval is not granted due to non-submission of complete compliance of the conditions stipulated in Stage-I/ in-principle approval. Hence, revised NPV rates to be collected from the user agency.

It this connection, it is submitted that, as per the instruction of the Prl. Chief Conservator of Forests, AP, Mangalagiri in the ref.4th cited, the District Forest Officer, Prakasam has issued a revised demand notice to the user agency for making the payment by generating an e-challan through the ministry's website vide ref.5th cited. A copy of the report of the Dist. Forest Officer, Prakasam with revised demand notice is submitted herewith for favour of kind information.

Revised DEMAND NOTICE

It is informed that in the reference 1st cited the Government of India has accorded approval in Principle (Stage I) for diversion of 1.79Ha of forest land in Prakasam (erstwhile Giddalur) Division for Up-gradation of NH-167 B from Km.86/540 to Km.87/340 i.e., from Porumamilla to Chandra Sekharapuram to two lanes with paved shoulders under NHDP-IV in the state of Andhra Pradesh in favour of the Executive Engineer, (R&B), NH Division, Kadapa subject to fulfilment of certain conditions.

In this regard, in the ref.6th cited, the conditions wise compliance report were submitted to the Prl.CCF,AP, Mangalagiri through the CCF, Guntur for taking necessary action.

In this connection in the ref.7th cited, the Prl.CCF, AP, Mangalagiri has instructed that the Compliance report to the conditions stipulated in Stage-I approval submitted by the user agency on 25.10.2023 (uploaded in online) is received in this office on 11.01.2024 through CCF, Guntur Rc.no.1980/ 2018/TO, dt.29.11.2023. Stage-II approval has not been granted even after lapse of 5 years due to non-submission of complete compliance of the conditions stipulated in Stage-I approval / in-principal approval granted on 30.11.2018 by the State Government.

As per the consolidated guidelines issued under Van (Sanrakshan Evam Samvardhan) Rules, 2023 and Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 at para no.3.3 of Chapter-3 (Net Present Value), the Prl.CCF, AP, instructed that to issue notice to the user agency to pay additional NPV or submit a detailed proposal for seeking one time exemption from Government of India for revised NPV for all such delayed projects and submit revised compliance report.

In view of the above, the following revised demand notice is issued to the User agency.

I. Amount demanded to be deposited in Adhoc CAMPA, Corporation Bank, Lodhi Road, New Delhi through e-challan only.

I. (a) Procedure for e- challan generation:

- i. On issue of this demand notice, the user agency shall log in to Forest Clearance portal **forestsclearance.nic.in** to generate e-challan and make payment against the demand.
- ii. Agency shall fill all the details as per the format provided in the portal and submit to Nodal Officer for verification.
- iii. Once it is verified by Nodal Officer, Agency can generate e-challan from the portal.

I. (b) Procedure for Payment through RTGS:


- iv. For payment through RTGS, the representative of the agency should visit his bank branch (RTGS enabled) of a Bank of his choice along with printed e-challan with an Account Number printed on it.
- v. While tendering the e-challan at the bank, the agency must ensure that the unique account number mentioned in the challan should be correctly mentioned as the account number in which funds to be remitted.
- vi. Upon executing the RTGS by the sender/ remitter bank, the amount collected will be credited to relevant CAMPA state account with the Bank on real time basis.
