I invite your attention to the references cited (copies enclosed).

- I inform that in the reference 1st cited, the Government of India, Ministry of Environment, Forests, Regional Office (SZ), Bangalore have accorded approval for diversion of 4.050 ha. of forest land in Compartment No.594 (part) & 596 (part), Mutchukota RF, Gooty Range, Ananthapur Forest Division, Anantapur District for mining of Steatite & Dolomite in favour of Sri Peram Nagi Reddy of Sri Sai Minerals, Tadipatri for a period of 10 years subject to certain conditions stipulated therein. Accordingly, State Government issued orders in the reference 2nd cited for diversion of said proposal.
- Based on the above, the mining lease was granted to the User Agency for period of (20) years with a condition that the User Agency shall submit forest clearance for further period of (10) years after expiry of 10 years period for which forest clearance is accorded vide G.O.Ms.No.245, I&C (M.III) Dept., dated 23.08.2003. The lease period is valid from 23.08.2003 to 22.08.2023. Accordingly, the Asst. Director of Mines & Geology, Tadipathri has executed lease deed with M/s Sri Sai Minerals in his proceeding No.852/M2/2003, dt.12.09.2003.
- Later, in the reference 3rd cited, the Government of India, Ministry of Environment, 4. Forests, Regional Office (SZ), Bangalore have accorded approval for renewal of forest clearance for diversion of 4.05 ha of forest land in Mutchukota RF, Ananthapur Division for extraction of Steatite and Dolomite in favour of M/s. Sri Sai Minerals, Prop.Sri Peram Nagireddy, for a period of (10) years with effect from 10.06.2012, subject to certain conditions stipulated therein. Accordingly, State Government issued orders in the reference 4th cited for renewal of forest clearance for the proposal. The lease period will be expired on 09.06.2022.

- 5. In the reference 5th cited, the Principal Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh, has submitted statutory proforma proposal under Forest (Conservation) Act, 1980, for grant of 2nd renewal of quarry lease over an extent of 4.050 ha of forest land in Compartment No.594/P & 596/P of Muchukota RF, Peddapappur Mandal, Ananthapuramu District for extraction of Dolomite & Steatite in favour of M/s. Sri Sai Minerals (Proprietor: Sri PeramNagi Reddy) along with Stage-II compliance report and requested to consider the renewal proposal and forward to Government of India, Ministry of Environment, Forests & Climate Change for taking necessary action under the Forest (Conservation) Act, 1980.

I request you to obtain and communicate the approval of Government of India, Ministry of Environment, Forests & Climate Change, under Section 2 of Forest (Conservation) Act, 1980, for 2nd renewal of forest clearance over an extent of 4.050 ha of forest land in Compartment No.594/P & 596/P of Muchukota RF, Peddapappur Mandal, Ananthapuramu District for extraction of Dolomite & Steatite in favour of M/s. Sri Sai Minerals (Proprietor: Sri PeramNagi Reddy), at an early date.
