As per the Principal Chief Conservator of Forests (HoD) reference 3rd cited above, approval (Stage I) was issued in the reference 1st cited, under section 2 of Forest Conservation Act, 1980 for the diversion of 0.198 Ha of forest land in Thirutheri RF for formation of an approach road subject to the following conditions.

1. As per condition in Para (ii) the demarcation of the proposed forest land shall be carried out the User agency by erecting 4 feet high cement concrete pillars duly numbered at an interval of 20 meters at their cost.

- 2.As per condition in Para (iii) in the reference 1st cited, State Forest Department shall carry out plantation and its maintenance of ten times the trees to be felled in the diverted forest area over Identified 0.25 Ha of degraded forest area of Appur RF of Chengalpattu Range at the cost of user agency. Accordingly for raising the fresh plantation 240 trees and maintenance for a period of 10 years, an amount of Rs.4,82,351/-(Rupees Four Lakhs Eighty Two Thousand Three Hundred and Fifty One Only) is arrived and user agency is requested to remit this amount under State CAMPA account.
- 3. Contingency fund to meet out the special nature of works for restocking of plantation in the event of drought, protection of plantation etc., @ 5% of total scheme cost of Rs.24,117/- (Rupees Twenty Four Thousand One hundred and Seventeen only) to be paid by the user agency. User agency is requested to remit this amount under State CAMPA account.
- 4. In respect of condition in Para (iv) NPV of the diverted land measuring 0.198 Ha to be paid. It is informed that at the rate of Rs.6,70,140/- per ha (as per the guidelines of the Government of India, Ministry of Environment Forest and Climate Change, New Delhi letter No.F-3/2011-FC(VoI-I) Dt.06.01.2022) the total cost of NPV for 0.198 Ha has been arrived at Rs.1,32,688/- (Rupees One Lakh Thirty Two thousand Six hundred and Eighty Eight only) and the same has to be remitted under the State CAMPA account.
- 5. The cost of 24 trees which is expected to yield of Rs.1413/- and user agency is requested to remit the same to District Forest Officer, Chengalpattu Division, Kancheepuram through Demand Draft.

As per condition Para (vi) It is requested to remit an amount of Rs. 6,40,569/- (Rupees Six Lakhs Forty thousand Five hundred and Sixty Nine Only). (Rs.482351+24117+132688) under the State
