In continuation to this office memo no. under reference it is to inform that it has been requested to deposit the compensatory levies in the CAMPA account of the state. Further, it is to mention that, in the context of mismatch of area considered for Penal NPV calculation, Chief Conservator of Forests (Nodal), O/o - the PCCF & HoFF, Odisha has issued guideline vide Memo no. 9957 Dt. 06.05.2025. Accordingly, Penal NPV has been calculated following the said guideline.

Hence, it is requested to deposit the following compensatory levies in the CAMPA Account of the State through PARIVESH web portal and intimate the deposit particulars to this office for taking further course of action at this end. Additional compensatory levies, if, any shall be intimated in due course of time.


