It is to informed that Government of India / Government of Telangana State, Hyderabad has accorded in -principle Stage-I approval for diversion of 3.15 Ha of Forest land in Jangamaipally Forest Block in Compt. No. 475, 476, 477, 479, & 485 in Wanaparthy Division – for Improvement and widening of road from Balijapally to Karne Tanda — in favour of Executive Engineer, PR Division, Wanaparthy.

User Agency
The Superintendent Engineer, RWS&S, TDWSP Circle, Mahabubnagar is requested to upload the above demand notice on the Ministries portal for vetting of Nodal Officer i.e., APCCF (FCA). After vetting and acceptance of the demand, the District Forest Officer, Wanaparthy can be raised the demand with the user agency and see that the payment can be done in e-portal method only. The mode for remittance of Compensatory levies shall be through **e-payment portal of Ministry of Environment, Forest & Climate change only**. The User Agency has to generate challan upon acceptance of demand raised & transfer funds through online only into any of the following Ad-hoc CAMPA accounts of Telangana state, the cost of NPV (**Rs. 19,71,900.00**) (total Cost: NPV 19,71,900.00+ ACA 3,00,000.00 = **Rs. 22,71,900.00**) towards Telangana Compensatory Fund (CAF) / Telangana State Compensatory Fund Management and Planning Authority (CAMPA) directly Through RTGS/NEFT mode only in SB A/c. No. 037100101029963 of Corporation

Bank, CGO complex, Lodhi Road, New Delhi - 110 003 (RTGS/IFSC No. CORP0000371) or in SB A/c. No. 344902010106351 of Union Bank of India, Sundar Nagar, New Delhi - 110003 (RTGS/IFSC No. UBINO534498) and report compliance. The detailed procedure for generation of Challan and deposition of funds is available at www.forestsclearance.nic.in portal.

The User Agency is also to pay an amount of **Rs 55000/-** (Rupees Fifty Five Thousand only) towards cost of extraction and transportation of trees in the proposed area and **Rs 11,16,000/-** (Rupees Eleven Lakhs Sixteen Thousand only) towards cost of construction of boundary pillars. The total amount of **Rs 11,71,000/-** is to be deposit with the District Forest Officer, Wanaparthy i.e **A/c No 62487358914 of State Bank of Hyderabad, Wanaparthy Branch.**

Hence the User Agency is further requested to submit compliance report on the conditions stipulated to by government along with all necessary enclosures in six sets in original so as to submit the compliance report to the Government for according the Stage-II approval. Until final approval is received the user agency should not take up any activity in the area proposed for diversion as it attracts the provisions of the Forest Conservation Act, 1980.
