With reference to the above subject, the Government of India, Ministry of Environment, Forest & Climate Change (Forest Conservation Division), New Delhi has accorded Stage-I / In-principal approval for Diversion of 4.74 hectare of forest land in DM Block, Sandur Taluk, Ballari District for use of existing approach road to MLNo. (0004) 2366 in favour of M/s. JSW Steel Limited, Toranagallu imposing certain conditions vide letter under Ref (1). In this regard, office of the undersigned had submitted the compliance report to condition imposed in Stage-I approval.

Further, the Government of India has raised EDS query vide letter Dt.05.07.2022 under Ref(1). In this regard, the Principal Chief Conservator of Forests (FC) and Nodal Officer (FCA), Aranya Bhavan, Bengaluru has directed the undersigned to submit certain information vide letter under Ref(5). The User Agency has requested to issue demand notice as per prevailing rates vide letter under Ref(6).

Further, there is a revision in the CA charges [Common Sanctioned Schedule of Rates (CSSR) in the year 2022-23] notified vide letter under reference (4). The differential Compensatory Afforestation, SMC works charges and Raising of Avenue Plantation charges as applicable for the above referred proposal are calculated as here under;
