Inviting a reference to the above cited correspondences on the captioned subject; you are requested to take follow up action immediately on the following aspect


1. Remit compensatory levies in favour of State CAMPA-Compensatory Afforestation Fund i.e., CAF, Odisha Account No. **520101263743655**, Corporation Bank, Lodhi complex Branch, Ground Floor, Block No.11, CGO Complex, Phase-I, Lodhi Road, New delhi-110003 through e-portal (<https://parivesh.nic.in>) mode as per details mentioned below:
 - a. Rs.25,24,032/- (Rupees Twenty-Five Lakh Twenty-Four Thousand and Thirty-Two) only @ Rs. 6,26,000/- per ha. towards Net Present Value (NPV).
 - b. Rs.32,92,000/- (Rupees Thirty-Two Lakh Ninety-Two Thousand) only towards cost of Compensatory Afforestation (CA).
 - c. Rs.1,26,20,160/- (Rupees One crore Twenty-Six Lakh Twenty Thousand and One hundred Sixty) only towards cost of (5) times of Penal NPV.

2. Pursue with the Tahasildar, Laxmipur for transfer and mutation of 4.172 ha. of non-forest land allotted for Compensatory Afforestation in Mouza- Panchada under Laxmipur Tahasil of Koraput District in favour of Forest & Environment Department, Government of Odisha.

Further you are requested to furnish an undertaking that you will deposit additional Net Present value (NPV) in case NPV will be revised by the Government of India, Ministry of Environment, Forest and Climate Change as per direction of the Hon'ble Supreme Court of India.


