Sub:- Diversion of 0.5772 ha of forest land for laying optical fibre cable M/s Jio Digital Fibre Private Limited., from Nurpur Bedi Village to Village Kalwan via Village Jattpur Village Gurse Majra, Village Kartarpur, Village Manku Majra, Village Dumewal Total length 12500 Mtr. under forest Division Rupnagar, Punjab FP/PB/ OFC/ 148987/2021/

Government of India has accorded general approval under the Forest Conservation Act, 1980 vide letter No. F.No. 5-2/2017-FC dated 28.03.2019 in under para 4.2 according in the cases of laying of Underground Telephone Lines, Optical Fiber Cable/Underground Laying of Drinking Water Supply Pipeline.

After careful consideration of the proposal submitted vide your letter under reference general approval of Govt. of India under Section 2 of Forest (Conservation) Act, 1980 for "Stage-1 approval" of temporary diversion of 0.5772 ha. of forest land measuring 12500 mtrs. Long, 1.65 depth and depth 0.45 mtrs wide along the road for laying of Optical Fiber Cable (Jio Digital Fibre Private Limited.) is hereby conveyed subject to the following conditions:-

- 1. Legal status of the forest land will remain unchanged.
- 2. The forest land to be diverted as per in-principle approval will not be used for any other purpose.
- 3. No tree will be felled by the user agency.
- 4. As per the order of the Hon'ble Supreme Court of India dated 28-3-08 in I.A No. 826 in 566.... in W.P.(C) 202 of 1995, the user agency is exempted for paying of the charges under NPV: (a) no felling of trees is involved; and (b) the areas fall outside National Park/Wildlife Sanctuary.
- 5. User Agency has given Bank Guarantee of Rs. 3,12,500/- to Divisional Forest Officer Rupnagar.
- 6. The Optical Fiber Cable will be laid along the road within the existing right of way and closed to the outermost edge of the forest land. The dug out land shall be restored by the User Agency and the same shall be made good immediately after the approved operation.
- 7. This approval is subject to the clearance of the proposal under relevant local

Acts/Rules/Court's Rulings/instructions etc. as applicable.

- 8. It is Mandatory for the User Agency not to exceed the permissible trench limit of 12500 meter Length, Width 0.45 meter and depth 1.65 meter.
- 9. The User Agency shall seek prior permission from the DFO, Rupnagar for carrying out any maintenance operation.
- 10. The User Agency shall abide by any other condition (s) that may be imposed by this Department in the interest of afforestation and protection of environment.
- 11. The State Forest Department may revoke/suspend this approval, if any of the above conditions is not satisfactorily fulfilled by the User Agency.
- 12. An undertaking is tendered by the User Agency for abiding all the aforesaid conditions.
- 13. If any other NOC is necessary for the work under any Act/Rules/Guidelines etc. from any other Departments, the user agency should obtain the same on its own before the commencement of laying of Cable.
- 14. This approval is granted to the condition that there is no court case pending in any Court pertaining to the land or trees in the present FCA case. Any legal liability arising out of such case; if any, will be the sole responsibility of the land owning Department/ Agency.
- 15. DFO, Rupnagar shall ensure fulfillment of the above conditions and CF, Shiwalik Circle will supervise it.
