In the reference 1st cited, the Govt. of India have accorded Stage-I (in principle) approval for "diversion of 0.12 Ha. Of forest land in Compt. No. 459, Guvvadi West RF, Udayagiri Range, Nellore Division for Laying Optical Fibre Cable in favour of M/s Vindhya Tele Links Ltd., Secunderabad" subject to certain stipulated conditions.

In the ref 2nd cited, the Chief Conservator of Forests, Guntur has approved the scheme for raising of 100 Nos.of trees in degraded Appasamudram RF of Udayagri Range to a tune of Rs. 5.00 lakhs.

As per the guidelines issued by MoEF &CC, Govt. of India vide File No. 5-3/2011 (Vol-I) dt. 6-1-2022 the NPV is exempted for laying of under ground Optical Fiber Cable provided that, if there is no tree felling and area falls outside the Sanctuary. As per this condition, NPV is exempted for this case.

In view of the above, the following demand notice is issued to the user agency.

(a) Procedure for e- challan generation:

- On issue of this demand notice, the user agency shall log in to (https://parivesh.nic.in/) to generate e-challan and make payment against the demand.
- ii. Agency shall fill all the details as per the format provided in the portal and submit to Nodal Officer for verification.
- iii. Once it is verified by Nodal Officer, Agency can generate e-challan from the portal.

I. (b) Procedure for Payment through RTGS:
