

With Reference to the above subject I am directed to state that in earlier order of Government of Karnataka dated: 26/08/2015 referred at (2) above. Sanction was accorded by the State Government for the above project on the basis report of the PCCF (HoFF) Bengaluru referred at (1) above, keeping in view the general approval letter of Government of India which permits the State Government for granting below 1.00 ha. of forest land for the purpose of construction of Public Toilet & Solid waste Management. Whereas Government of India MoEF&CC vide their letter dated: 22/06/2016 referred at (3) above has given direction to withdraw the sanction order stating that proposal does not come under the purview of General Approval. Hence the State Government has withdrawn the sanction order on 30.11.2017. In the instance I am directed to forward the very same proposal herewith for the approval of the Government of India, and it is requested to kindly accord In - principle Stage-I approval u/s (2) of the Forest Conservation Act, 1980 and communicate at the earliest for further proceedings in this regard.
