In continuation to this office No:- 4501-03/BFD Dated;- 16.12.2022 you are requested to deposit the following amount of NPV, CA & Addl. CA as per conditions as laid down in *In-principle* approval accorded in respect your online proposal No FP/JK/ROAD/151949/2022 for diversion of 0.99 ha of forest land for above mentioned project, as under;

1. Cost of Compensatory Afforestation (CA) at the tune of Rs. 8.46 lacs together with Net Present Value (NPV) of the forest land being diverted amounting to Rs. 12.80 lacs and cost of stabilization of muck dumping site Rs 0.661 lacs, totaling to Rs 21.921 lacs. The said amount be deposited through web portal of Ministry of Environment and, Forest and climate change www.parivesh.nic.in. It will be ensured that this amount is deposited through Challan generated online on web portal and deposited in appropriate bank only. Amount deposited through other mode will not be accepted.
2. FRA Certificate from competent authority be also submitted.
3. The use of forest land will be allowed only after final approval is accorded as laid down at condition No.3 of In-principle approval.


