Further it is submitted that, the user agency has paid an amount of Rs. 49.32932 Lakhs towards cost of CA vide reference 6th cited for the above project, hence the balance amount to be paid is Rs.65.72763 Lakhs (Rs.115.05695 Lakhs – Rs.49.32932 Lakhs = Rs.65.72763 Lakhs).

As per the Government of India condition No. (x) the user agency should compulsorily deposit the CA by generating challan through the Ministry's website. Hence, the User Agency is requested to deposit the cost of NPV, CA etc. through online mode into the Telangana State Compensatory Afforestation Fund Management and Planning Authority (CAMPA) bank account, by uploading the demand notice against the project for approval by the Nodal Officer (FCA) and generate challan after approval of demand notice. The payment has to be made against the number mentioned in the Challan number. A step-by step process for deposition of funds is available at https://parivesh.nic.in.

Therefore the Vice Chancellor, Sri Konda Laxman Telangana State Horticulture University, Mulugu(V&M), Siddipet District is requested to pay Addl. payment under CA for an amount of Rs. 65.72763 Lakhs and furnish the details of payment for obtaining Stage-II (final) approval.
