Kind attention of the District Panchayath Raj Engineer, (PIU) Kumram Bheem Asifabad District, Asifabad is invited to the references cited above, vide reference 6th cited the Demand notice issued to the User Agency for the above subject/project and requested to deposit the cost of NPV, CA etc. through online mode into the Telangana State Compensatory Afforestation Fund Management and Planning Authority (CAMPA) bank account, by uploading the demand notice against the project for approval by the Nodal Officer (FCA) and generate challan after approval of demand notice. The payment has to be made against the number mentioned in the Challan number. A step-by step process for deposition of funds is available at parivesh.nic.in and also requested to intimate the details of payments made and submit (8 sets) of compliance report on all the conditions stipulated in Stage-I approval along with all the necessary documents, certificates, undertaking etc., for onwards submission to the competent authority for issue Stage-II approval.

But, till-to-date the User Agency has not submitting the condition wise compliance report on (Stage-I) approval along with remittance particulars of demand notice and required information/ connected documents. Due to non-receipt of the same, a report to the higher authorities is held up.

Further, the User Agency is once again requested comply with the following in accordance with the MoEF & CC, GoI instructions issued vide F.No.7-23-2012-FC, Dated: 24.07.2013 communicated vide PCCF., Hyderabad Rc.No.45921/2001/F4, Dt: 23.08.2013.

- 1. Publish the entire forest clearances granted to the project proponent for the use of forest land for the non-forest purpose in verbatim along with the conditions and safeguards imposed by the Central Government in two widely circulated daily newspaper i.e., one is vernacular language and the other in English.
- 2. The copies of the clearance should also be submitted to the heads of local bodies, Panchayats and Municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days from the date of receipt of this reference.

The transfer of forest land to User agency **shall not be affected** prior to the issue of final approval (or) working permission whichever is earlier.

Early action is requested.
