I (a) Procedure for e-challan generation:

- 3. Once it is verified by the Nodal Officer, the user agency can generate e-challan from the portal.

Further, it is requested to the Project Director, Project Implementation Unit, Machilipatnam, Krishna District to submit the compliances as per the conditions stipulated in the reference 1st to 3rd cited with condition wise relevant proofs / under takings in shape of (3) sets for onward submission to the Prl.Chief Conservator of Forests, (HoFF), Guntur through the Chief Conservator of Forests, Guntur Circle, Guntur for further necessary action and for obtaining the final approval.
