As per para 3.5 of the Handbook of the Forest (Conservation) Act, 1980, there is exemption of NPV for laying of Optical Fiber Cables (OFC) within ROW of the road Hence, the demand raised vide this office letter cited above at the ref (3) above is withdrawn.

Government of India / Government of Karnataka vide letter number F.No:FEE 95.FLL 2022(e) dated: 02.09.2022 have issued in-principle Stage-1 approval for diversion of 2.2318 ha of forest land in 23 villages of Hallyal Division (Joida, Dandeli, Virnoli, Sambrani, Bhagwathi & Haliyal Range) of Uttar Kannada District subject to conditions of approval mentioned therein.
