**Sub: Proposal for diversion of 13.22 Ha. of forest land for Construction of Khurda Road-Bolangir New BG Rail Link Project from Km. 180-238**

**Ref:** Memo no. 9977 dt. 10.05.2022 of Conservator of Forests, (Nodal) O/o the Pr.C.C.F, Odisha, Bhubaneswar to your address & memo no. 1749 dt. 21.05.2022 of R.C.C.F, Berhampur Circle addressed to this office.

With reference to the above cited memos on the captioned subject, it is to inform that, the CA scheme over an area of 26.44 Ha. Degarded forest land identified in Subarnagiri RF under Boudh Range and Additional CA scheme over an area of 13.26 Ha. Degraded revenue forest land identified in Balakira village pertaining to above project amounting to ₹ 26,97,700/- & ₹ 43,87,500/- respectively approved by PCCF (FD & NO, FC Act) at the wage rate of ₹ 308/- per MD with 10 years maintenance. Further, Avenue Plantation Scheme for 116 RKM has been approved @ ₹ 315/- per MD amounting to ₹ 10,87,99,555/- by R.C.C.F, Berhampur Circle with 10 years maintenance.

Due to revision of wage rate the above CA schemes have been revised at the wage rate of ₹ 326/- per MD and approved by the Chief Conservator of Forests, FD & NO, FC Act for ₹ 31,46,900/- & ₹ 45,86,000/- respectively and the Avenue plantation scheme has been revised at the wage rate of @ ₹ 326/- per MD amounting to ₹ 11,02,20,370/- by the R.C.C.F, Berhampur Circle.

Hence, you are requested to deposit the differential cost of Compensatory afforestation Schemes and Avenue Plantation scheme as per the following demand details **through PARIVESH web portal in State CAMPA Account** and intimate the deposit particulars to this office for taking further course of action at this end. Copies of the approved financial outlay are enclosed herewith for your information and necessary action.


