- 2. The area involved has been declared as a Reserved Forest vide Government of Gujarat Notification No. AM-144/MFLD-3862/104210-P, Dt.04/02/1965.
- 3. 9903 trees are required to be cut in the demanded area. Girth and species wise list is attached herewith. User Agency have to transplant maximum number of possible trees under the supervision of concerned DCF at its own cost.
- 4. The user agency shall arrange to raise strip plantation on either side of the road and central verge at project cost, as per IRC specification, with maintenance of 7-10 years. The user agency shall also submit design of providing at least 2-3 rows of long rotation indigenous trees, as per provision of IRC-SP-21-2009 (Guidelines on landscaping & tree plantation), on either side of the road before final clearance.
- 5. There is no violation of Forest (Conservation) Act, 1980 as Certified by the concerned Deputy Conservator of Forest.
- 6. The Project area is 1.95 Km. away from the Ful Ki Nar Sanctuary.

- 8. Compensatory Afforestation is proposed at 55.00 ha. degraded forest land at. Villages- Demti & Devasan (Bolundra, Ruvach) S.No.12 & 81, Ta.Poshina & Idar, Dist-Sabarkantha
- 9. Site inspection report of the Project area is provided by the concerned Deputy Conservator of Forest.
- 10. User Agency has obtained Forest Right Act, 2006 certificate from Collector, Sabarkantha.
- 11. Principle Chief Conservator of Forest(Land) and Nodal Officer(FCA), Gujarat State, Gandhinagar has recommended the proposal.

In light of the circumstances explained in the above paragraphs and enclosures, the Government recommends that the said forest land may be allowed to be diverted for the non-forestry use under Section-2 of the Forest (Conservation) Act, 1980.
