- The area involved has been declared as a Protected Forest vide Government of Gujarat Notification No. GHKH-70/VNM-1073/68147/P, Dt.15/03/1978.
- 4083 trees are required to be cut in the demanded area. Girth and species wise list is attached herewith. User Agency will have to transplant maximum number of possible trees under the supervision of concerned DCF at its own cost.
- There is no violation of Forest (Conservation) Act, 1980 as Certified by the concerned Deputy Conservator of Forest.
- The Project area is 133.00 Km. away from the Balaram-Ambaji Wildlife Sanctuary.
- User Agency has submitted undertakings to defray the Cost of Compensatory Afforestation, Net Present Value and any increase thereof.
- Compensatory Afforestation is proposed at 80.00 ha. degraded forest land as per below Details.
