It is to inform that, the Stage-I approval was accorded by the GoI for Diversion of 0.21 ha. of Forest land in favour of Divisional Engineer, OFP, BSNL, Vijayawada for laying of optical fibre cable between Eluru and Kaikaluru for providing high speed communication & data services to Govt. and non-govt. and public use in favour of Divisional Engineer, OFP, BSNL, Vijayawada. The Principal Chief Conservator of Forests & HoFF, Andhra Pradesh, Guntur while communicating stage-I clearance issued instructions, to obtain and furnish compliance from the user agency on the conditions stipulated in stage-I approval vide reference 2nd cited.

Further, as per condition no A.1 & A.2 mentioned in stage -I clearance, the user agency shall transfer online, the Net Present Value(NPV) of the forests land being diverted under this proposal, as per the orders of the Hon'ble Supreme Court of India, dated:28-03-2008,24.04.2008 and 09-05-2008 in Writ petition(Civil) No.202/1995 and the guidelines issued by this Ministry vide its letter No.5-3/2007-FC dated 05.02.2009.The requisite funds shall be transferred through online portal(<u>https://parivesh.nic.in/</u>) into CAMPA account of the state concerned. Amount deposited through other mode will not be accepted as compliance of the stage-I clearance.

In this connection, it is informed that, the area applied for diversion is falling along the berm portion of Eluru to Kaikaluru R&B road and it is part of the Kolleru Wildlife Sanctuary. No vegetation is present in the area proposed for diversion, the nearest forest area is Ramasingavaram RF of Eluru Range in Eluru (T) Division which is approximately 25km away from the proposed area and is classified as Eco class-IV and the density of the forests in that RF is 0.60 (Dense category).

Hence, the following amounts are to be deposited to the Adhoc CAMPA Account. The details are as follows.

1. Amount demanded to be deposited in Adhoc CAMPA account Corporation Bank, Lodhi Road, New Delhi through e-challan only.

1. (a) Procedure for e-challan generation:

- 1. On issue of this demand notice, the user agency shall log on into <u>https://parivesh.nic.in/</u> to generate e-challan and make payment against the demand.
- 2. Agency shall fill all the details as per the format provided in the portal and submit to Nodal Officer for verification.
- 3. Once it is verified by Nodal Officer, Agency can generate e-challan from the portal.

1. (b) Procedure for Payment through RTGS:

- 1. For payment through RTGS the representative of the agency should visit his bank branch (RTGS enabled) of a Bank of their choice along with printed e-challan with an Account Number printed on it.
- While tendering the e-challan at the bank, the agency must ensure that the unique account number mentioned in the challan should be correctly mentioned as the account number in which funds to be remitted.

3. Upon executing the RTGS by the sender/remitter bank, the amount collected will be credited to relevant CAMPA state account with the Bank on real time basis.

Further, the user agency is requested to submit the payment particulars along with stage-I condition wise compliance report at the earliest to take further action in this matter.
