"With reference to the subject cited above, stage-I approval granted in ref. No.1 & 2 cited above "Diversion of 0.38 ha forest land in sy. No. 135, Halathi village, in Kasaba Hobali, Nagamangala Tq, Mandya District for construction of Approach Road to Malikarjunaswamy Temple in Nagamangala Tq, Mandya District" in favour of Deputy Director, Torism Department P.E.S Engineering College Road Mandya. In this connection the demand notice has been issued vide dated 10-02-2022. (Ref.6)

As per Ref (7), OM regarding the revised cost of Felling of trees has been issued. In this connection the demand notice is rejected and instructed to issue revise demand notice under Ref (8).

Accordingly, the demand notice issued vide Ref no (6) dated: 10-02-2022 stands withdrawn and revised demand notice is being issued as per orders in ref. No (3), (7) & (8).

Therefore, you are hereby requested to make payments through e-payment module of forest clearance portal "Pariveshinic.in" as per the direction of the Government of India and as per this office demand notice by uploading this demand notice for acceptance by the Principal Chief Conservator of Forests (Head of Forest Force), Bangalore and get the Challan generated from the said portal.

Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supree Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government to the User Agency. The User Agency has to abide to that and shall furnish an undertaking to this effect.

After the completion of the payments process, you are requested to submit the compliance report to this office for further needful action.
