In inviting kind reference to the above cited memo nos on the captioned subject, it is to inform you that due to revision of wage rate from Rs. 308/- MD to 311/- MD, the financial outlay of Compensatory Afforestation has been revised from Rs. 40,72,100/- to Rs. 40,94,400/- which is technically approved by the Conservator of Forests(Nodal) O/O the Pr.CCF, Odisha, Bhubaneswar .

As such it is requested to deposit the differential amount of Rs. 22,300/- (40,94,400 -40,72,100/- = 22,300/-) through the account of State CAMPA managed by the Ministry of Environment of Forests, immediately. Further, you are requested to take immediate action to transfer 10.58 hec. of non-forest land in favour of Forest and Environment Department in consultation with the concerned Tahasildar and Revenue Authorities .


After receipt of the above, the same shall be sent to the higher authorities for final approval.


