In continuation to this office letter cited above, the revised Net Present Value (NPV) of the forest area diverted is to be deposited by the User Agency at the rate applicable as per Condition No. A (i) of Stage-I/in-principle approval order of Govt. of India, MoEF & CC, IRO, Bhubaneswar vide letter No.5-ORC463/2021-BHU dtd.28.12.2021 against the aforementioned diversion proposal. The demand for payment of revised NPV is being raised in respect of 19.621 Ha. of forest land being diverted in Ghumsur North Division out of the total area of 27.343 Ha. Hence, the detail of NPV value of 19.621 Ha. of diverted forest land is furnished below:-



With reference to the above cited letter under subject, it is to inform you that integrated Regional office of MoEF&CC Govt. of India vide their letter no- 5-ORC-463/2021-BHU dt 28.12.2021 have accorded in principle approval under section -2 of the Forest (Conservation) ACT 1980 for non forestry use of 27.343Hc of forest land for widening of NH-157 project in Kandhamal and Ganjam District. Out of 27.343Hc of total diverted forest land, 7.722Hc of forest land comes under jurisdiction Phulbani forest Division of Kandhamal District.

Hence as per condition No. A(i) of the approval order of the Govt. of India, MoEF&CC you are requested to deposit an amount of Rs. 72,50,958/- (Rupees seventy two lakh fifty thousand nine hundred fifty eight) only towards the cost of Net Present Value(NPV) for approved non forestry use of 7.722Hc of forest land pertaining to Phulbani forest Division as per as the calculation given below.


The above said NPV should be transferred through online portal in CAMPA Account of the State concerned.
