Sub:- Proposal for diversion of 14.928 ha. of forest land for construction of Sono Barrage project at Jaida of Gopobandhu Nagar Tahasil of Mayurbhanj District, Odisha within the Jurisdiction of Balasore(wl) & Baripada Forest Division (Proposal No.FP/OR/IRRG/12731/2015)-Request for raising demand for the differential cost of the compensatory levies-regarding.

With reference to the subject cited above it is seen that, you have already been deposited a sum of Rs. 17, 89,600/- (Rupees Seventeen lakh eighty nine thousand six hundred) only for compensatory afforestation against diversion of 14.928 Ha. forest land for construction of Sono Barrage at Jaida of Gopobandhu Nagar Tahasil, Mayurbhanj vide Cheque No. 249703 dated 28.03.2018 in the wage rate @ Rs.200/- per mandays but the total amount approved by PCCF is Rs.19,99,300/- (Rupees Nineteen lakh ninety nine thousand three hundred) only in the wage rate @Rs.308/- per mandays. So, you are requested to deposit the balance differential amount of Rs.2,09,700/- (Two lakhs nine thousand seven hundred only) through e-portal of the MoEF & CC as provided in the <http://parivesh.nic.in> and submit the proof evidence of amount deposited to this office at an early date.

Similarly it is also seen that, you have already been deposited 4,34,73,000/- (four corer thirty four lakh seventy three thousand only) for catchment area treatment plan vide Cheque No.249702 dated 28.03.2018 in the wage rate @Rs.200/- per mandays but the total amount approved by PCCF, Odisha is Rs.6,24,43,400/- in the wage rate @Rs.308/- per mandaya. So, you are requested to deposit the balance differential amount of Rs.1,89,70,400/- (Two lakhs nine thousand seven hundred only) through e-portal of the MoEF & CC as provided in the <http://parivesh.nic.in> and submit the proof evidence of amount deposited to this office at an early date.


Sir,

The differential amount has been calculated to Rs.2,54,100/- (Two lakh fifty four thousand one hundred) only.


An early action on the matter is solicited.
