I am to say that the Central Government vide letter No.3-MN C 011/2022-SHI/3124-25 dated 6th February, 2023 (copy enclosed) accorded "In- Principle/Stage-I Approval" for diversion of 76.097 ha of Forest Land for Widening and Improvement of Package- III of Imphal-Jiribam Road Section of NH-37 (NH-53) into two laning of existing of 33+395 km from Longa Koireng village to Kangpokpi district to Ch. 67+496 km near Khumji Village of Noney district in the State of Manipur by NHIDCL subject to the fulfilment of the stipulated conditions.
