I am directed to enclose a copy of the references 1<sup>st</sup>, 3<sup>rd</sup> and 5<sup>th</sup> cited. The Principal Chief Conservator of Forests (HoFF) in his letter first cited has stated that, the M/s.Reliance Jio Infocomm Limited, Chennai, has uploaded online forest clearance proposal for diversion of 0.03132 ha. of forest land in Villupuram Forest Division for laying of underground Optical Fibre Cable along road side of Royandapuram to Melsiruvallur road section via. Perungolathur in Thandarampattu-Sankarapuram ODR road across Pavunji pattu Reserved Forest in Villupuram District (now in Kallakurichi District) under the proposal No.FP/TN/Others/38123/2019.



2. In the Part-II of Form-A, the District Forest Officer, Villupuram Division has furnished the following particulars:-

- i. The legal status of the proposed site of diversion of 0.03132 ha of forest land requested for the project is Reserved Forests and name of the forest land reported as Pavunjipattu Reserved Forest.
- ii. Density of the forest area is 0.2 and Eco class of forest area is two.
- iii. Species wise and girth class wise enumeration of trees in the area is Nil.
- iv. On vulnerability of the forest land proposed for diversion, the District Forest Officer has reported that there is no vulnerability to erosion.
- v. Spotted deer, Wild boar, Hare, Peacock etc., are present in and around the forest land proposed for diversion. The forest area proposed for diversion is not forms part of National Park, Wildlife Sanctuary, Biosphere Reserve, Tiger Reserve, Elephant corridor, Wildlife migration corridor etc., and not located within the eco-sensitive zone of the protected area notified under Wildlife (Protection) Act, 1972 and not located within 1 km boundary of National Park/Wildlife Sanctuary etc., for the forest land proposed for diversion. There is no rare / endangered / unique species of flora and fauna found in the area.
- vi. There is no protected archaeological / heritage site / defense establishment or any other important monument is located in the area.
- vii. Requirement of forest land as proposed by the User Agency is unavoidable and bare minimum for the project and no work in violation of the Act or guidelines has been carried out.
- viii. As per Forest (Conservation) Act, 1980 guidelines under special provisions for Compensatory Afforestation for certain categories of schemes. Compensatory Afforestation shall be raised and maintained at the cost of user agency on degraded forest land twice in extent of forest area diverted for laying of telephone / optical fibre cable.

For the proposed diversion of 0.03132 ha of forest area Compensatory Afforestation scheme has been proposed for planting of 100 number of saplings in the degraded forest area identified in Thagarai Reserved Forest at a total cost of Rs.5,70,302/- including maintenance of plantation over a period of 10 years. Certificate regarding suitability of compensatory afforestation land has been furnished in the project proposal. On further clarification, the Principal Chief Conservator of Forests (HoFF) has stated that, the District Forest Officer has withdrawn the Compensatory Afforestation scheme proposed for the project proposal based on the guidelines issued by the Government of India, Ministry of Environment, Forests and Climate Change in letter No. FC-11/118/2021-FC, dated 13.06.2023, since the diversion of forest area is less than one ha. On further clarification, the Principal Chief Conservator of Forests (HoFF) has stated that the District Forest Officer, Villupuram Division has uploaded compensatory afforestation for Rs.1,75,231/- for planting and ten year maintenance of 100 No.of seedlings planting in the degraded forest area in Mallapuram Reserved Forest in Villupuram Division.

- ix. In the site inspection report, the District Forest Officer has stated that, site inspection carried out on 07.11.2022. Laying of Optical Fibre Cable proposed along the high way road side from Royandapuram to Melsiruvallur road section over a distance of 1044m across Pavunjipattu Reserved Forest in Kallakurichi District. It is existing older high way road. There is no tree felling involved in this project. There is



no hindrance to the Flora and Fauna. There is no felling of spontaneous tree species. There is no elephant corridor. Area required for the project is 313.2 sq.m or 0.03132 ha.

- x. The District Forest Officer, Villupuram Division has reported that, it is public project. This project is very essential to effective function of the network communication in future and hence recommended.

3. The Principal Chief Conservator of Forests (HoFF) has stated that the Conservator of Forests, Villupuram Circle has inspected the area on 24.11.2022 and in his recommendation has stated that the proposed laying of Optical Fibre Cable falls adjacent to existing road in Pavunjipattu Reserved Forest, hence this proposal recommended.

4. The Principal Chief Conservator of Forests (HoFF) has stated that the User Agency has requested forest area diversion for a period of 99 years. The District Forest Officer, Villupuram Division has recommended this proposal for the year 2022 and Conservator of Forests, Villupuram Circle has recommended the diversion of forest area for a period of 25 years. Based on the recommendation made by the Conservator of Forests, for laying of underground Optical Fibre Cable work in the forest area, diversion of forest land is recommended for 25 years.

5. The Principal Chief Conservator of Forests (HoFF) has stated that in Government of India guidelines of Forest (Conservation) Act, 1980 in F.No.5-3/2007-FC, dated 05.02.2009, full exemption for payment of Net Present Value for underground laying of Optical Fibre Cable has been allowed for areas falling outside National Park / Sanctuary and there is no felling of trees involved. As per the details furnished by the District Forest Officer, there is no tree felling involved in this project proposal and area falls outside National Park / Sanctuary, hence payment of Net Present Value of forest area may not be insisted.

6. The Principal Chief Conservator of Forests (HoFF) has stated that the State Government may accord diversion of forest land of less than one hectare in each case for non-forestry purposes under the Forest (Conservation) Act, 1980, for creation of critical development and security related infrastructure of Government Departments under the general approval of Forest (Conservation) Act, 1980 guidelines. In this case, though the forest area diversion is less than one hectare, the project proponent / user agency is a Private company, hence, approval of Government of India is required under Forest (Conservation) Act, 1980 for forest area diversion to private entity.

7. The Principal Chief Conservator of Forests (HoFF) has also stated that, the proposal is sent through parivesh portal duly recommended by the Additional Principal Chief Conservator of Forests (Forest Conservation Act) / Nodal Officer of Forest (Conservation) Act of the State of Tamil Nadu in Part-IV of Form-A.

8. Based on the recommendations of the District Forest Officer, Villupuram Division, Conservator of Forests, Villupuram Circle and Additional Principal Chief Conservator of Forests (FCA), the Principal Chief Conservator of Forests (HoFF) has recommended the proposal for diversion of 0.03132 ha of forest land in Villupuram Forest Division for laying of underground Optical Fibre Cable along road side of Royandapuram to Melsiruvallur road section via Perungolathur in Thandarampattu-Sankarapuram ODR road across Pavunjipattu Reserved Forest in Kallakurichi District in favour of M/s.Rliance Jio Infocomm Limited, Chennai for a period of 25 years, and requested the Government to forward the same to Government of India for obtaining their approval for the project proposal, subject to the following conditions:-

- i. The legal status of the diverted forest land shall remain unchanged.



- ii. The demarcation of the proposed forest area shall be carried out by erecting 4 feet high cement concrete pillars, duly numbered, at the appropriate distance as decided by the District Forest Officer, Villupuram Division at the cost of user agency.
- iii. The user agency has to pay the cost towards compensatory afforestation scheme selected in Thagarai Reserved Forest of Villupuram Forest Division.
- iv. The User has to bear the additional amount of Net Present Value which will be fixed as per the guidelines of Hon'ble Supreme Court of India as fixed by Forest Department in future.
- v. Amount of Compensatory afforestation scheme under the project shall be transferred / deposited to CAMPA fund only through e-portal (<https://parivesh.nic.in/>).
- vi. The User Agency has to pay the cost towards lease rent for the forest area diversion period as fixed by the Forest Department at the time of sanction along with any escalation for the forest land to be diverted of ~~the above project in future for the entire project period.~~
- vii. The total forest area utilized for the project shall not exceed 0.03132 ha for laying Optical Fibre Cable to a length of 1044m with a width of 0.30m along the existing road side of Royandapuram to Melsiruvallur road section via Perungolathur in Thandampattu-Sankarapuram ODR road across Pavunjpattu Reserved Forest in Kallakurichi District.
- viii. Period of lease can be twenty five (25) years. The User Agency has to apply renewal proposal before one year of expiry of lease with the State Forest Department.

9. The Government have examined and accept the proposal (FP/TN/Others/38123/2019) of the Principal Chief Conservator of Forests (HoFF) for diversion of 0.03132 ha of forest land in Villupuram Forest Division for laying of underground Optical Fibre Cable along road side of Royandapuram to Melsiruvallur road section via Perungolathur in Thandampattu-Sankarapuram ODR road across Pavunjpattu Reserved Forest in Kallakurichi District in favour of M/s.Reliance Jio Infocomm Limited, Chennai for a period of 20 years, under section 2 (1) of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980, subject to the following conditions and decided to recommend and forward the same to the Government of India, Ministry of Environment, Forests and Climate Change, Chennai for obtaining their concurrence:-

- i. The legal status of the diverted forest land shall remain unchanged.
- ii. The demarcation of the proposed forest area shall be carried out by erecting 4 feet high cement concrete pillars, duly numbered, at the appropriate distance as decided by the District Forest Officer, Villupuram Division at the cost of user agency.
- iii. The user agency has to pay the cost towards compensatory afforestation scheme selected in Thagarai Reserved Forest of Villupuram Forest Division.
- iv. The User Agency has to bear the additional amount of Net Present Value which will be fixed as per the guidelines of Hon'ble Supreme Court of India as fixed by Forest Department in future.
- v. Amount of Compensatory afforestation scheme under the project shall be transferred / deposited to CAMPA fund only through e-portal (<https://parivesh.nic.in/>).
- vi. The User Agency has to pay the cost towards lease rent for the forest area diversion period as fixed by the Forest Department at the time of



- sanction along with any escalation for the forest land to be diverted of the above project in future for the entire project period.
- vii. The total forest area utilized for the project shall not exceed 0.03132 ha for laying Optical Fibre Cable to a length of 1044m with a width of 0.30 m along the existing road side of Royandapuram to Melsiruvallur road section via Perungolathur in Thandampattu-Sankarapuram ODR road across Pavunjpattu Reserved Forest in Kallakurichi District.
- viii. Period of lease is twenty (20) years. The User Agency has to apply renewal proposal before one year of expiry of lease with the State Forest Department.

10. I am, therefore, directed to request you to kindly obtain the concurrence of the Competent Authority and communicate the same to this Government, early.

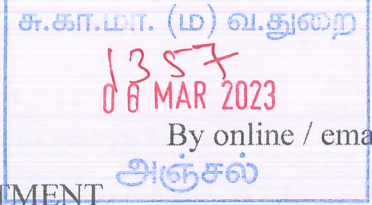

I wish to state that, M/s Reliance Jio Infocomm Limited, No. 89, Dr. Radhakrishnan Salai, Mylapore, Chennai - 4 has uploaded online forest clearance proposal under Section 2 of Forest (Conservation) Act, 1980 for diversion of 0.03132 ha of forest land in Villupuram Forest Division for laying of underground Optical Fiber Cable along road side of Royandapuram to Melsiruvallur road section via Perungolathur in Thandarampattu-Sankarapuram ODR road across Pavunjipattu RF in Villupuram District (now in Kallakuruchi District) under proposal No. FP/TN/Others/38123/2019.



Brief details of the project are given below.

i) The User Agency has uploaded the proposal in the prescribed format of Form A - Part I - under Section 2 of the Forest (Conservation) Act, 1980 for diversion of fresh forest area.

ii) In the short narrative of the proposal for which forest land is required, the User Agency has reported that diversion of forest land is required for laying of optical fiber cable along road side of Royandapuram to Melsiruvallur road section via Perungolathur in Thandarampattu-Sankarapuram ODR road across Pavunjipattu RF in Villupuram District.

iii) M/s Reliance Jio Infocomm Limited, having Office at No. 89, Dr. Radhakrishnan Salai, Mylapore, Chennai-4 has applied forest clearance proposal and for applying forest clearance proposal authorisation has been issued to the State Coordinate Officer.

iv) Diversion of 0.03132 ha of forest has been requested in Villupuram Forest Division area in erstwhile Villupuram District (now in Kallakuruchi District). Name of the village reported as Perungolathur for 0.03132 ha forest area and component wise break up reported as Linear.

v) Location map of the forest land proposed to be diverted in kml file of google earth, Scanned copy of Survey of India topo sheet indicating the boundary of forest land proposed to be diverted, Scanned copy of Geo referenced location map has been furnished.

vi) The user agency has proposed forest area diversion for laying of optical fiber cable along road side of Royandapuram to Melsiruvallur road section via Perungolathur in Thandarampattu-Sankarapuram ODR road across Pavunjipattu RF in Villupuram District to a length of 1044m to trench width of 0.30m. (Area 313.2 sq.m or 0.03132 ha).

vii) The User Agency has stated that this project does not involve displacement of people due to the project and not requires clearance under the Environment (Protection) Act, 1986.

viii) The user agency has stated that the project or part thereof is not located in any protected area or their Eco sensitive zone.

ix) The User Agency has furnished the certificate issued by the District Collector, Kallakuruchi District about completion of process for settlement of rights



under Forest Rights Act, 2006 on the forest land proposed for diversion in Ref. No. B7/2529/2021, dated 21.06.2022

x) The user agency has furnished following certificates/ undertakings/ details under additional Information details section.

a) Certified that, there is no work in violation of Forest (Conservation) Act, 1980 has been carried out in the project area.

b) Certified that forest land requested is the minimum required for the project and all other alternatives have been examined and found not feasible.

c) Undertaking to pay the Net Present Value of forest land required for the project.

d) Undertaking to pay the additional amount of Net Present Value of forest land demanded subsequently.

e) To bear the cost of raising and maintenance of compensatory afforestation and or penal compensatory afforestation as well as cost of protection of plantation as per the scheme prepared by the Government of Tamil Nadu in lieu of RF land diverted for the project and to deposit additional amount if any suggested as amended owing to change in planting technique, enhancement in FSR etc.,

f) Undertaking to pay the cost along with any escalation for exploitation of trees if any available in the alignment path.

1) The District Forest Officer, Villupuram Division has forwarded the proposal along with Site Inspection report and recommendation of the proposal to the Conservator of Forests, Villupuram Circle on 11.11.2022 through online.

i) The legal status of the proposed site of diversion of 0.03132 ha of forest land requested for the project is Reserved Forests.

As per the site inspection report and recommendation of the project uploaded by the District Forest Officer, Villupuram Division, name of the forest land reported as Pavunjpattu RF.

ii) The District Forest Officer has reported that, density of the forest area is 0.2 and Eco class of forest area is two.

viii) As per Forest Conservation Act, 1980 guidelines under special provisions for CA for certain categories of schemes, CA shall be raised and maintained at the cost of user agency on degraded forest land twice in extent of forest area diverted for laying of telephone/optical fibre cable. ✓

8) Based on the recommendation made by the District Forest Officer, Villupuram Division and Conservator of Forests, Villupuram Circle, proposal received from the M/s Reliance Jio Infocomm Limited, Chennai for diversion of 0.03132 ha of forest land in Villupuram Forest Division for laying of underground Optical Fiber Cable along road side of Royandapuram to Melsiruvallur road section via Perungolathur in Thandarampattu-Sankarapuram ODR road across Pavunjiattu RF in Kallakuruchi District, seeking approval under Section 2 of Forest (Conservation) Act, 1980 is furnished to the Government for consideration and obtaining orders from the Government of India subject to the following conditions.

i) The legal status of the diverted forest land remains unchanged.

ii) Demarcation of the proposed forest area shall be carried out by erecting 4 feet high cement concrete pillars, duly numbered, at the appropriate distance as decided by the District Forest Officer, Villupuram Division at the cost of user agency.

iii) The user agency has to pay the cost towards compensatory afforestation scheme selected in Thagarai RF of Villupuram Forest Division

iv) The User Agency has to bear the additional amount of Net Present Value which will be fixed as per the guidelines of Hon'ble Supreme Court of India as fixed by Forest Department in future.

v) Amount of Compensatory afforestation scheme under the project shall be transferred/ deposited to CAMPA fund only through e-portal (<https://parivesh.nic.in/>).

vi) The User Agency has to pay the cost towards lease rent for the forest area diversion period as fixed by the Forest Department at the time of sanction along with any escalation for the forest land to be diverted of the above project in future for the entire project period.

vii) The total forest area utilized for the project shall not exceeds 0.03132 ha for laying Optical Fibre Cable to a length of 1044m with a width of 0.30 m along the existing road side of Royandapuram to Melsiruvallur road section via Perungolathur in Thandarampattu-Sankarapuram ODR road across Pavunjpattu RF in Kallakuruchi District.

viii) Period of lease can be twenty five (25) years. The User Agency has to apply renewal proposal before one year of expiry of lease with the State Forest Department.


9) I request that, the proposal may be considered and forwarded to the Government of India for obtaining concurrence for diversion of 0.03132 ha of forest land in Villupuram Forest Division for laying of underground Optical Fiber Cable along road side of Royandapuram to Melsiruvallur road section via Perungolathur in Thandarampattu-Sankarapuram ODR road across Pavunjpattu RF in Kallakuruchi District in favour of M/s Reliance Jio Infocomm Limited, No. 89, Dr. Radhakrishnan Salai, Mylapore, Chennai -4 for a period of 25 years.

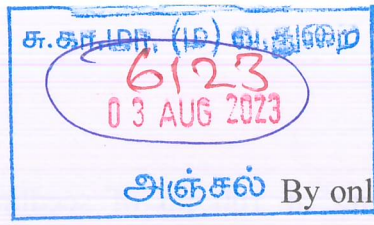



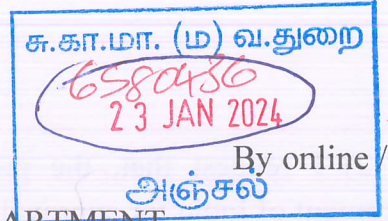
