With reference to the above subject, the Ministry of Environment Forests and Climate Change, Government of India has accorded 'in principle' approval (Stage-I) under Section-2 of Forest (Conservation), Act-1980 for Diversion of 14.8457 ha of forest land for downhill pipe conveyor belt (from our mines MLNo.2296 to sushilanagar railway siding) of ramanamalai iron ores mine of M/s. Veerabhadrapa Sangappa and Company, Sandur vide letter under reference(1).
