It is submitted that, the District Panchayat Raj Engineer (PIU), Mancherial vide reference 4th cited has requested to issue the demand note for process the further necessary action regarding Diversion of 2.2745 Ha (Revised from 3.2493) of Forest land for Laying of BT Road from MRL01-Nennel to Kushnepally via Konampet of Chennur RF of Bellampalli Division of Mancherial District in favour of District Panchayat Raj Engineer (PIU), Mancherial –In-principle (Stage-I) approval-Accorded vide reference 3rd cited above.

Further it is submitted that, the Principal Chief Conservator of Forests (HoFF), Telangana Hyderabad vide reference 1st cited has stated that, regarding non-forest land identified in Sy. No.BDPP of Indhani village of Kerameri Mandal of Kerameri Range of Asifabad Division is adjacent to compartment Nos 67 & 28 of Manikgarh RF of Kerameri Range. The land free from encroachments. It is classified as non-forest in village record. The land is in a compact block and in close proximity of RF Area of Manikgarh Reserve Forest. The land now proposed has not been proposed or recommended to any other assignment of alternate land for any department. The land is having 0.3 to 0.5 density with good vegetation and is a hillock with rocky terrain, hence raising of CA is not proposed in this land and same is proposed over Degraded Forest land as per the guidelines.

The District Forest Officer, Kumuram Bheem-Asifabad under whose jurisdictions the CA land falls has prepared Compensatory Afforestation scheme for raising with 10-year maintenance (i) with a financial outlay of Rs.293.598 lakhs, proposing to protect non-forest CA land by erecting Chain link fencing, boundary pillars and SMC works i.e., SCTs., and taking up cultural operations and fire management works identified to an extent of 39.84 ha in Sy. No.BDPP of Indhani village of Kerameri Mandal of Kerameri Range falling in Asifabad Division and (ii) 40.00 ha in degraded Forest land in Compt No.134 Raspally Beat of Raspally Section of Kaghaznagar Range falling in Kaghaznagar Division with a financial outlay of Rs.322.708 lakhs, for raising plantation with 1111 plants/ha with 10 years maintenance as per the guidelines. It is proposed to utilize equivalent non-forest CA land for this project from total CA land fouls suitable and CA scheme prepared. As now, there is balance of 21.8284 ha of CA land. The proportionate CA scheme amount for diversion of 2.2745 ha of forest land comes to Rs.16.7618 lakhs. Out of 21.8284 ha of non-forest CA land identified for PMGSY roads, 19.5539 ha still remains after utilizing equivalent non-forest CA land for this project. The details of CA land and CA scheme so far utilized for these proposals under PMGSY Road is as follows.

Further, the User Agency will be requested to deposit the cost of CA etc. through online mode into the Telangana State Compensatory Afforestation Fund Management and Planning Authority (CAMPA) bank account, by uploading the demand notice against the project for approval by the Nodal Officer (FCA) and generate challan after approval of demand notice. The payment has to be made against the number mentioned in the Challan number. A step-by step process for deposition of funds is available **at parivesh.nic.in**.

Further, the User Agency will be requested to intimate the details of payments made and submit seven sets of compliance report on all the conditions stipulated in Stage-I approval along with all the necessary documents, certificates, undertaking etc., for onwards submission to the competent authority for issue Stage-II approval.

Further, the User Agency will be requested comply with the following in accordance with the MoEF & CC, GoI instructions issued vide F.No.7-23-2012-FC, Dt.24.07.2013 communicated vide PCCF., Hyderabad Rc.No.45921/2001/F4, Dt: 23.08.2013.

- 1. Publish the entire forest clearances granted in verbatim along with the condition and safe-guards imposed by the Central Government in two widely circulated daily newspaper i.e., one is vernacular language and the other in English granted to the project proponent for the use of forest land for the non-forest purpose.
- 2. The copies of the clearance should also be submitted to the heads of local bodies, Panchayats and Municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days.

In view of the above, it is requested to kindly accord permission to raise the above demand notice to the User Agency.
