Sub: - TSFD – Forest (Conservation) Act, 1980- Diversion of 4.8409 Ha (4.0977 Ha in Chennur Division and 0.7432 Ha in Bellampally Division) of forest land for improvement of existing road to BT Standard from 6/600 to 8/800 km on RF Laxmipur of Vemanpally Mandal (including construction of two bridges) Chennur RF of Chennur and Bellampally Forest Divisions of Mancherial District in favour of District Panchayath Raj Engineer (PIU) Mancherial –In-principle (Stage-I) approval accorded – **Demand Notice issued** – Regarding.

It is submitted that, vide reference cited In-Principle (Stage-I) approval accorded for diversion of 4.8409 Ha (4.0977 Ha in Chennur Division and 0.7432 Ha in Bellampally Division) of forest land for improvement of existing road to BT Standard from 6/600 to 8/800 km on RF Laxmipur of Vemanpally Mandal (including construction of two bridges) Chennur RF of Chennur and Bellampally Forest Divisions of Mancherial District in favour of District Panchayath Raj Engineer (PIU) Mancherial subject to certain conditions stipulated therein.

Further the CA Non-Forest land area for 70.00 Acres (28.45 Ha) in Sy.No. 67/1 of Venkatapur village of Mudhole Mandal of Nirmal Division & District is identified for diversion of (07) Road Proposals of Panchayath Raj Engineer Department and (01) VTC Proposals of Municipal Commissioner, Nirmal and the amounts are estimated for compensatory levies of Cost of total CA of Non-Forest land area for 70.00 Acres (28.45 Ha), cost of raising of CA, Construction of Boundary Pillars etc., and as per the approved CA scheme the total amount of 694.92941 Lakh Rupees and for the project requirement of 4.8409 Ha including all aspects of CA NFL land (4.0977 Ha in Chennur Division and 0.7432 Ha in Bellampally Division) the details of part payment are as shown below :

The User Agency will be requested to deposit the compensatory levies towards CA etc. into the Telangana State Compensatory Afforestation Fund Management and Planning Authority (CAMPA) saving bank Account of Telangana State, through online mode only, through e-portal method at MoEF&CC, GOI, New Delhi portal i.e., <http://parivesh.nic.in> by generating the challan in consultation with Nodal Officer, Telangana State Forest Department. The user agency needs to upload the demand notice against the project for approval by Nodal Officer (FCA), Telangana and generate challan after approval. The payment to be made against the Challan number and the Challan is valid for one week. A step-by-step process is available at <http://parivesh.nic.in>.

In view of the above it is requested to pay an amount of Lakh 118.231 rupees as shown in the table above immediately for taking up further necessary action.

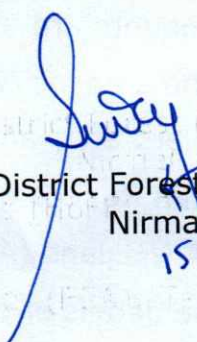
